There was discussion regarding a Mobile VHF Radio for use in the township vehicle. It would be based out of Delaware County. The county has offered to lend the township a handheld to use for a trial period. The handheld does not have as strong of a signal as the mobile unit that is mounted in the vehicle and there is concern the signal would not reach to all of Oxford Township. After discussion a motion was made by Lewis and seconded by Pittman to do a trial period with the handheld then purchase either the mobile unit or handheld up to a value of \$1,200.00.
