Whereas, each November, National Adoption Month is celebrated through combined efforts of the Children's Bureau, AdoptUSKids and the Child Welfare Information Gateway; and

Whereas, in 1984, President Ronald Reagan proclaimed the first National Adoption Week, designed to create a national awareness about adoption and waiting children and youth; and

Whereas, this year's National Adoption Month theme is "In Their Own Words: Lifting Up Youth Voices." It is well known that teenagers are less likely to be adopted, often because of their age, and are much more likely to age out of foster care without strong or stable family support. Securing lifelong connections for teens in foster care, both legally and emotionally, is a critical component in determining their future achievement, health, and well-being; and

Whereas, The Delaware County Department of Job & Family Services currently has 21 licensed foster to adopt families, with home studies being completed on two other families at present. We continue to recruit and

license individuals in our community who choose to serve waiting children and youth. These families gladly accept our phone calls during the wee hours of the morning, ready to take on the challenges of a child coming into their home, while doing so with open hearts and arms; and

Whereas, in 2018, we have successfully facilitated the finalization of 5 adoptions, with one or two more finalizations possible by year's end. The oldest child was 6 and the youngest was 2. We have two youth placed in Florida and await their adoption finalization in early 2019; they waited for their forever family for 5 years. We have 7 children/youth in permanent custody. Two will be adopted by their foster parents, while the other 5 youth are teens with a variety of behavioral health diagnoses, making them more difficult to place permanently.

Now, Therefore, Be It Resolved the Board of Commissioners of Delaware County, Ohio wish to recognize and honor our children and our families by proclaiming November as National Adoption Month 2018 in Delaware County.
