RECORD OF PROCEEDINGS Minutes of the Special Meeting is to Discuss Trash Service Contracts and Conduct any Other Regular Business if Necessary Held July 31, 2019 at 1:00 P.M.., Page 559

The special meeting of the Board of Trustees of Oxford Township was called to order by Chairman Pittman.

Roll call: Ed Pittman, present; Steve Lewis, present; Jim Hatten, present. Also present: Terry Thompson with Republic Services, Eric Webber with Rumpke, Taylor Greely with Rumpke, Stephanie Matrunick, resident and Heather Matrunick, resident.

Terry Thompson announced that the sale of the Oxford Township trash contract to Rumpke will go in to effect on August 1, 2019. The current contract and pricing will remain the same with Rumpke. The contract will expire on June 30, 2022. A copy of the pricing list was given to Eric Webber.

There was discussion with the trustees and Rumpke representatives Eric Webber and Taylor Greely regarding the following:

- Trustees asked that Rumpke send a letter to all of the Oxford Township residents informing them of the change. Rumpke agreed to the mailing.
- Rumpke stated the trash pick-up day for the week may change but they will give plenty of notice to the residents.
- Fiscal Officer Leienberger will send to Taylor Greely an address list of the residents of Oxford Township along with contact information of the trustees and herself.
- There was discussion regarding the current billing. Terry Thompson stated that Republic Services will not bill after August 1, 2019. Fiscal Officer Leienberger stated she received a bill for the dumpster at the township hall for the month of August. Eric Webber with Rumpke said not to pay it and he will be checking in to the billing to make sure it is correct. Residents will be billed from Rumpke starting on August 1, 2019.

Stephanie Matrunick and Heather Matrunick addressed the issue of trach pick-up at Wooley Park. Because of the condition of their common drive their service was cancelled with Republic Services. They have fixed the drive with new gravel and have enough gravel for a turn-a-round if necessary. Eric Webber said he will drive over and take a look it. He asked Stephanie if she could be the contact person and will work with her in trying to resolve this issue. Rumpke may schedule the pick-up at Wooley Park on the same day that they pick-up the Village of Ashley.

Taylor Greely stated if any resident needs new service or has any questions regarding their service, they are to contact customer service at Rumpke. Taylor will send a list of contact names with their information along with the customer service number to Fiscal Officer Leienberger.

This concluded the business for the special meeting and a motion was made by Lewis and seconded by Hatten to adjourn. Vote: all yeas. Motion carried.
