Fiscal Officer Leienberger presented the following resolution; A RESOLUTION TO PROCEED WITH SUBMISSION OF THE QUESTION OF LEVYING A 0.6 MILL TAX IN EXCESS OF THE TEN-MILL LIMITATION FOR THE PUROSE OF CURRENT EXPENSES. The tax is for current expenses at a rate not exceeding .6 mills for each one dollar of valuation, which amounts to six cents (\$0.06) for each one hundred dollars of valuation, for five (5) years and which the levy is a replacement of an existing levy of .6 mills commencing with the 2019 tax year, first due in calendar year 2020. A motion was made by Hatten and seconded by Lewis to adopt the resolution. Vote: All yeas. Resolution adopted. Fiscal Officer Leienberger is hereby directed to certify the levy to the Auditor and the Board of Elections, Delaware County, Ohio. Certification shall include copies of all of the following documents: Resolution of Necessity (Resolution No. 05-2019-04 adopted on May 14, 2019; and, Certification of the Auditor; and, this Resolution to Proceed.

Duane Matlack updated the trustees on the following:
