Trustee Stegner made a motion to approve the July 13, 2021 agenda as amended. Trustee Skinner seconded. Motion passed.

#### Fiscal Officer's Report:

Fiscal Officer Peggy Link reported that the First Commonwealth checking account balance is \$205,785.06 and earned \$3.43 in interest. Star Bank balance is \$1,336,875.51 and earned \$88.03 in interest. She passed around the reconciliation checklist and timesheet and EFT listing for review and approval for June 2021. Fiscal Officer Link shared that the Brown Township Hall rental agreement has a discrepancy between the maximum occupancy that is set for the hall and what is in the contract. Trustees discussed that the maximum occupancy should be listed and she'll revise and present the updated contract at the next meeting.

#### **Delaware County Engineer:**

Mr. Riedel presented the Trustees with the OPWC Contract with The Shelly Company for \$215,111.22 and Trustees signed the agreement. Fiscal Officer Link inquired about the split of funding and was advised that this has been agreed upon. Mr. Reidel advised the Trustees that the culvert replacement on Hogback Road is behind schedule due to equipment issues. Mr. Reidel shared the estimate for the Harris Road Grader Patch and Berm REA. Trustee Skinner made a motion to approve accepting the estimate for \$27,754.30 for Harris Road Grader Patch and Berm as long as we move the road work schedule from 2023 to 2024. Trustee Miley seconded. Motion passed.

#### **Public Participation:**

Prosecutor Melissa Schiffel attended the meeting. She wanted to remind the Trustees about the ARP funding and that her office would be working on putting out additional information regarding the use of those funds. She also reminded everyone of the training her office supports in December for Trustees, Fiscal Officers and Zoning Inspectors.

#### **Zoning Inspector:**

Zoning Inspector Kuba went over her report. Gotts trying to transfer property to Caldwell. Ms. Kuba has submitted her resignation effective October 31, 2021. Trustees discussed conducting an exit interview. Ms. Kuba shared she would work to obtain information on Zoning Inspectors and Board member salary information. Trustees discussed with Ms. Schiffel resolving any outstanding cases in regards to resident issues before Ms. Kuba leaves her position. This would be specific for the Devoe property on Bowtown Road. Ms. Schiffel will work to get this moving. She also indicated that her office would be implementing a ticket system in order to track where requests were at when requested. Fiscal Officer Link will send out the position description she has on file for the Zoning Inspector for everyone to review.

#### **Road Superintendent:**

Road Superintendent Gladman shared his report. Mr. Gladman inquired about maintaining Oxford Woods and when that would occur. The little truck is at Byers having the glow plugs installed. Lawrence Hardin complained about vehicles parking at the curve on Beard Road.

#### Roads

The Cea culvert can be removed from the agenda. Trustees discussed Harris Road berming and discussed potential solutions in regards to berming.

#### Cemetery

Cemetery Sexton Harp was absent. Trustee Skinner shared an update. There were 3 burials and 1 would be occurring Thursday. Maintenance removed bushes by a monument after approval from the family. Trustee Skinner discussed the flagpole at the back and wondered why it wasn't at the front. Longstreth Wilbert looked at 120 foundations and gave an estimate of \$9,700 to fix those foundations/monuments. The grant has a cost share requirement to cover half of the expenses. Fiscal Officer Link shared that we have appropriated \$10,000 for site improvements. Wendy French with Wichert shared that we have two options and we could look at Affordable Care Act (ACA) rates. This would require every elected official and all full-time employees to fill out a census form. The insurance company would then look at ACA rates that will be high but coverage is guaranteed or medically unwritten rates and these may be more affordable but it's dependent upon the health of the group. Fiscal Officer Link asked for guidance from the Board regarding an outstanding payment due from Brian Secrest who damaged a property at the Eden Cemetery on January 13, 2020. Asst Prosecutor Mark Fowler asked his investigator to try to locate Mr. Secrest with no success. It would cost about \$150 to take this case to small claims court but if we cannot locate him we would only be spending more money. Trustees agreed to not pursue Mr. Secrest further. Lastly, Fiscal Officer Link shared that Brown Township was apparently included in the Opioid Settlement case and that we need to respond to the Prosecutor's office if we want to participate. The maximum amount of funds we would receive would be \$16.62 and those funds have to specifically be spent on opioid prevention. This amount of money doesn't begin to even pay for posters. Trustee Miley reminded everyone that the first culvert inspection is free but adding another drive would cost the homeowner. If he doesn't fix or file the correct documents then we can proceed with default. The township would have to front he impound cost. Resident Virdiana Leonard attended the meeting and asked the Trustees to discuss the mowing letter her husband and she received. She wants a written letter indicating that no action will be taken since she has tried to mow some of the weeds. The mower broke because of the mowing. Trustee Miley cited Ohio Revised Code 505.87 that gives the relevant information on the responsibility of the property owner and the township for mowing. Trustee Miley just asked for the weeds to be mowed down. Ms. Leonard has in good faith put in the effort and wants to take care of it next summer. They do not have the financial capacity/budget to cover the expense. Trustees suggested using whatever she needed to cut down the weeds. It doesn't have to be done by a mower. She would like the Trustees to consider her extenuating circumstances and feels that they are not. Trustee Miley was notified her over a month ago. Trustee Skinner shared that it is the township's responsibility to ensure that residents maintain their property. Per the Ohio Revised Code a letter could be sent to the lien holder and give a date to have the weeds mowed and then if not compliance the township would mow and charge to the homeowner's property taxes. Trustees reinforced that the weeds on the mound are the worse. They would like her to show progress in the next 2 months and before it snows. They need to show continuing effort and the mound is the priority and needs to be completed by November 1, 2021. Ms. Leonard wanted until December 1st. Trustees all agreed that the work is to be done by November 1st.

#### **New Business:**

Trustees inquired with Assistant Prosecutors Fowler and Fligner on selling the old township hall. Could they use a realtor, auction, or property switch and Mr. Fowler confirmed that any of these options would work.

Trustee Miley is planning to generate mowing letters for the following properties after consensus with the Board: 5120 Leonardsburg Road, 4072 N. Old State Road, 3320 Cackler Road and Henmick Farms. He will give them 2 weeks to complete the work and then if not completed he will proceed with a certified letter to the lien holder only if needed.
