WHEREAS, Little Brown Jug Joseph Neville Memorial Award recipients are chosen and inducted by a panel of international harness racing enthusiasts each year; and

WHEREAS, this year's Joseph Neville Memorial Award is awarded posthumously to Thurman Downing, who was the owner of the 1973 Little Brown Jug champ Melvin's Woe; and

WHEREAS, Mr. Downing graduated from Case Western Reserve University and served as an Army Ranger during the Korean War. He later became President and CEO of Downing Coal Company; and

WHEREAS, Mr. Downing was actively involved in breeding and training Standardbreds, owning a breeding farm in Coshocton County as well as Downwyn Farms in Wellington, Ohio. His father, Richard, owned Bret Hanover, the 1965 Triple Crown winner and three-time Horse of the Year; and

WHEREAS, Mr. Downing was a director of the United States Trotting Association, Harness Racing Hall of Fame, and a member of the Little Brown Jug Society. He passed away in May 2019 at the age of 87.

NOW THEREFORE, be it resolved that the Delaware County Board of Commissioners honors and applauds Thurman Downing for his exemplary career in the field of horse racing with the presentation of this proclamation.

It was moved by Mrs. Lewis, seconded by Mr. Benton to approve the following

WHEREAS, standardbred owners Mickey and Sylvia Burke are the principals of the Burke Racing Stable and have owned four Jugette winners and a pair of Little Brown Jug champs — Limelight Beach in 2014 and Filibuster Hanover in 2017; and

WHEREAS, despite the Burkes' relatively late start as full-timers in the harness racing industry, they have enjoyed tremendous success since selling their car dealership in 1981. Their success includes a run of 3,167 training wins and \$35.5 million in earnings between 1991 and 2008; and

WHEREAS, the Burke Racing Stable is the definition of a family operation, where five of Mickey and Sylvia's children have, at one time or another, worked in the barn with their parents. In 2009, Mickey turned his training operation over to his sons Ron and Mickey, Jr., and daughter Michelle oversees the operations of their Washington, Pennsylvania, farm. The Burkes' two other daughters, Melissa and Becky, worked for the stable while in high school and college; and

WHEREAS, prior to 2021, the Burke Racing Stable has entered 23 horses in the Little Brown Jug, winning \$1.2 million in purses. The Burkes also have won 10 heats of the Jugette, an Old Oaken Bucket, three Standardbreds' and 17 Ohio Breeders Championship events.

NOW THEREFORE, be it resolved that the Delaware County Board of Commissioners honors and applauds Mickey and Sylvia Burke for their exemplary careers in the field of horse racing with the presentation of this proclamation, recognizing them as the 36th Little Brown Jug Wall of Fame honorees by the Delaware County Fair.
