ELECTION NEWS - Connie Skinner - Trustee

Voting now takes place in the Township hall located at 5555 State Route 521. We have a primary election coming up on May 3rd. There may be a special election on August 2nd. And general election is November 8th. You must be registered to vote or have your voter profile updated if you have moved or changed your name at least 30 days in advance of an election to cast a regular ballot. If you fall under that 30 days, you will be able to vote by provisional ballot only. This takes more time to do, but your vote does gets counted. At this time we are not sure if there will be one primary, if there will be a split primary or the date will be moved. This will be dependent on how quickly the voting maps are completed and approved

TOWNSHIP ROADS - Charlie Miley - Trustee

The township will be experimenting with a new road improvement this year. The treatment is called micro-surface. This is a coating that seals and helps level the roadway and returns the crown that helps shed water to the berm. We will be trying this on both Veley and McCurdy roads. We are also going to improve the berms as part of the county road program in the future. The trustees will be conducting the spring road inspection with the assistance of our county road advisor in April. As you all know we have all experienced significant rain fall this spring. The first big storm dumped two inches on frozen ground and then a week or so later we had an inch and three-quarters. I had several calls about high water on lawns and fields. It is a misconception that the road ditch is to drain lawns and other private property, but the ditch's sole purpose is to keep water away from the road base. This is one of the main reasons the township does not allow the ditches to be filled. According to the Ohio Revised Code townships cannot improve drainage on private property. We have been around to check on the properties in question to look at the situation and will be working on the ditches where needed.

The Board of Trustees are pleased to sponsor Clean-up Brown Township Days. This event is made possible through a grant from DKMM (the solid waste organization), the County Commissioners and the township. Trash vouchers will be available May 1st and they are valid until May 31st. You can request one voucher per household and that voucher will be good for disposing of up to one ton of trash from that household. Anything over one ton will be your responsibility

Why zoning?

So, it's spring and soon we'll be headed into summer. I'll bet we're all more than ready to get outside and do stuff. It's a great time of the year to tackle all those projects on the to-do list, and this is where zoning may come into play.

Some people think that the role of zoning is an adversarial one, but let me assure you that it is not. I live in this township as a neighbor and a friend. We establish and enforce zoning rules for a reason: to protect our community. If you're like me, you like to keep property values up and make Brown Township a nice place.

Keep in mind that your township zoning department is not a homeowners' association. Zoning is not about forcing everyone to have the same mailboxes, telling you where you can and cannot put a planter, or nitpicking your property. It's simply about keeping our community a great place to live. Here's an example of why we have zoning rules: Let's say your neighbor wants to build a shed in their front yard right next to your front yard. They have a right to have a shed, of course, but it's unlikely that you (or any of us) would like seeing it placed smack-dab in the middle of the front yard.

So, if you're going to build a shed, put up a fence, get a new garage, or add a swimming pool, keep in mind that your project may be subject to zoning rules and you may need a permit. We have updated the fee schedule to make it easier to understand and some of the fees have been adjusted to reflect modern building innovations, as well as in keeping with best practices for townships in our surrounding area.

Here are some highlights of recent changes:

- * Carports are limited to 1 per property and there are now 2 different fees based on size.
- *. Accessory structure permits under 100 sq. ft. are \$25.
- *. Relocating any existing structure is \$25 and requires a permit.
- * Solar panels are now their own category.
- *. On-ground solar arrays fall under Brown Township Zoning Resolution Section 7.05 H. Maximum Lot Coverage.

Brown Township maintenance is performed by three part-time personnel, the Township Trustees, and private agencies when the need is present. The Maintenance Department is equipped with a variety of equipment including two dump trucks with snow plows, backhoe, skid steer loader, large tractor with a boom mower, a zero turn mower, and various other pieces of small equipment. This equipment is used to maintain 20+ miles of roads, two cemeteries, township buildings, and the townshipPark area.

The Maintenance Department has many different duties it performs on the township roads and township properties: plowing and salting roads, repairing potholes, cleaning ditches, trimming trees in the right-of-way, mowing roadside ditches, cemetery mowing and maintenance, opening and closing graves, mowing and maintenance of other Township properties, among other things.

To keep the road right-of-way clear many trees will have to be trimmed. This is mostly done with a large brush cutter mounted on a tractor; this is a very rough cut, not a clean cut. However it is a cost efficient way to maintain right-of-way clearance. The preferred time to do this is early spring so the spring growth will cover the rough edges of the branches making it not so unsightly. Once again "The preferred time" but this doesn't always happen due to other duties that may need to be performed.

Roadside mowing is done a minimum of three times a year prior to Memorial Day, Independence Day, and Labor Day. Additional mowing will be performed as needed.

Please be patient and pass with caution when you see workers on the road for their safety and yours.

We have been talking about it for some time now and it seems that we are finally closer to reality. The first week of March we opened bids for the new station to be located on the Bowtown Road side of the Byxbe Campus.

Despite what you may have read, the move is based on helping the city and state with what they call the "Point Project". Delays in their project slowed our progress in determining financing needs and finalizing dates for the move. With all of that behind us, we will be moving into a temporary facility just east of our current station. The plan for that move to occur is early July 2022. Construction on the new station should be underway by the time you read this arcticle.

The new engine we ordered has arrived, we are completing the outfitting and working on training the staff. This engine will become primary engine at Station 331. It is replacing an engine that is a 2008. In the 12 years since that was built, new technology has become available, with that in mind we are going to make certain everyone is prepared to work on this apparatus.

Spring has arrived, time for the spring clean-up. The burning of brush has guidelines created by the State EPA. Please call one of the stations to get further information. The farming community will be hitting the fields again, please give them some room on the roads as they plant crops.

HEALTH DEPARTMENT

The Partnership for a Healthy Delaware County is looking for community residents to be part of the upcoming countywide community health assessment. This health assessment process will start June 9 and continue over three additional meetings this summer which will lead to a new community health improvement plan starting in 2023.

Conducting community health assessments is one of the essential services for public health and is typically done every five years in Delaware County. The Partnership for a Healthy Delaware County is the community coalition led by the Health District and is made up of various sectors - schools, community organizations, healthcare, Fire/EMS, business etc.



Delaware County EMS received the highest rating from the American Heart Association for another year in a row. Delaware County EMS was awarded the Mission Lifeline Gold Plus award, which is in response to our treatment of cardiac and stroke patients in Delaware County. Delaware County EMS is awaiting the delivery of (4) new Ambulance to replace aging vehicles in our fleet. Due to supply chain issues, the timeline on delivery is unknown. Delaware County EMS recently finished up another round of simulation training where our employees had hands on cardiac training, which included a debrief with our training team and medical directors.

RECYCLING - Charlie Miley - Trustee

The township realized an increase in the amount of material recycled this year. In 2020 we tallied 158,158. In 2021 the total increased to 177,600 or an increase of 9.7 tons. Recycling bins are located behind the township hall and are dumped Monday, Wednesday, and Friday mornings. With the recycling bins being in Kilbourne no one is more that five miles away from the bins. Please help out and not throw plastic bags with recyclables in the bins and save more room by breaking down your cardboard boxes. History of Ohio Townships

The Pilgrim fathers brought the township form of government to America in 1620. This unit of local government eventually spread as far west as the Rocky Mountains. Today, it is found in 22 states, known as the town or townships

In Ohio, the township predates our state government. The townships' size and shape were determined by the Congressional Acts, which established the various land grants. As the Ohio territory became populated, it was only natural that the seuveyed townships should become the basic unit of local government.

In 1804, the elected officials of a township consisted of three trustees, a clerk, two overseers of the poor, and a sufficient number of highway supervisors, in addition to justices of the peace and constables. A township treasurer and assessor were later added. In the early years of statehood, Ohio townships carred for the poor, maintained the roads and preserved the peace.asis; however, their

Today, just as in 1804, the township is a political subdivision of the state. To keep pace with the demands of changing times, the functions, duties, and obligations of the townships have changed over the years. Demands for encreased or different services have prompted the state legislature to grant Ohio's 1,308 townships the authority to fulfill these changing needs.

Three trustees and a fiscal officer, each elected to a four-year term, administer our townships today. In addition, some townships now appoint a township administrator, whose duties are defined by the individual township. The township administrator typically helps plan, coordinate and implement township goals.

Elected officials fill their roles on a part-time basis; however, their intimate knowledge of their community; its needs and its citiens enables them to offer more personal service than any other unit of government.

Townships today are responsible for fire and police protection, parks and recreation, zoning, cemeteries, waste disposal, maintaining roads and more.
