DATE, TIME, AND PLACE FOR THE VIEW AND PUBLIC HEARING FOR THE CONSIDERATION OF THE DRAINAGE IMPROVEMENT PETITION FOR VILLAGE AT HARVEST WIND CONDOMINIUMS, FILED BY VILLAGE AT HARVEST WIND CONDOMINIUMS

Notice is hereby given that the Delaware County Board of Commissioners received a petition signed by Village at Harvest Wind Condominiums, to generally improve the drainage, both surface and subsurface, to a good and sufficient outlet by replacing, repairing, or altering the existing improvement as required and/or creating new surface and subsurface drainage mains or laterals, and to maintain these improvements per the associated engineering drawings as requested by this petition. In Delaware County, Genoa Township, within the Williams-Miller-Holmes #2 watershed and generally following, but not limited to, the course and termini of the existing improvements inclusive of the existing flood control improvements within the Village at Harvest Wind Condominiums. The petition also requests the Board of Commissioners consider consolidation of the petition with the Lanetta Lane Drainage Improvement Petition per the provisions of the Ohio Revised Code Sec 6131.13.

If the petition is approved, all costs of engineering, construction and future maintenance will be assessed to the benefiting parcels of land.

Any owner may comment on the proposed improvement in writing before or in person at the public hearings on the petition.
