### DATE, TIME, AND PLACE FOR THE FINAL PUBLIC HEARING FOR THE CONSIDERATION OF THE NORRIS RUN WATERSHED DRAINAGE IMPROVEMENT PROJECT

Notice is hereby given that the Delaware County Engineer has filed with the Clerk of the Board the plans, reports, and schedules for the construction of the Norris Run Watershed Drainage Improvement Project. The proposed project is located in Delaware County, Radnor and Troy Township, within the Norris Run Full Watershed and generally following, but not limited to the course and termini of the existing improvements. Additional laterals by the name of Prugh Main 517, Hadley Main (534) 109, Price Main 179, Shaw Main 13, Lewis Main 130, Miller 538, Klee 13, and Wilson Main 87. The nature of the proposed project is to generally improve the drainage, both surface and subsurface to a good and sufficient outlet, by replacing, repairing or altering the existing improvements as required and/or creating new surface and subsurface drainage mains or laterals as requested in the petition.

Notice is hereby given that the Board will conduct the final hearing on the report of the County Engineer, and on the proceedings for the improvement, on Monday May 8, 2023, at 1:30 P.M., at the Office of the Board of County Commissioners, 91 North Sandusky Street Delaware, Ohio. The Board shall also hear any evidence offered by any owner for or against the granting of the proposed improvement at this hearing.

Notice is hereby given that, if the Commissioners direct the County Engineer to proceed with the project, all costs of engineering, construction and future maintenance will be assessed to the benefiting parcels of land.

Plans, reports, and schedules for the construction may be examined by contacting the Delaware Soil and Water Conservation District directly at 740-368-1921, for the Resource Conservation Program.

Any owner may comment on the proposed improvement in writing before or in person at the public hearings on the petition.
