Checks written to Reggie and then once he gets them he'll send them to Wreath's Across America and then WAA will ship wreaths via UPS and then next day will be ceremony. They will remain in place for the entire month of January and then we'll remove them. It will be a 501(3)© setup. He'll be advertising on face book, at school reunion and get enough money for every veteran. A flag pole is currently on an individual grave site. Mr. Langford would like to propose a lighted flag pole and the shrubbery in the background and then a placque for each service area. Mr. Langford will foot the bill and maybe an Eagle Scout help with the project. Working at the cemetery was his first job and he remembers paying attention to the veteran graves. Mr. Langford would like the Trustees to place the flagpole (digging and placing the sleeve in a hole). Looking for a flag pole with a solar light so it would be lit all the time. Have nice round bushes. The area around the flag pole would be where the Wreaths Across America ceremony. Mr. Langford wants to gets everything setup for this year and then hopefully in the future another volunteer would step up to continue the practice. The Trustees are very supportive of this initiative. Purple heart recipient and the first injured from Delaware County from Vietnam War.

ZI Lisano has been invited to a technical review meeting regarding Beachwood Estates and the review will be on May 16th. 70-acre property and neighbors across the street asking what's happening and is it going into the woods. A concern is there is a 2" waterline on the north side of 3 B's & k and there is concern regarding water pressure. They have approval to run an 8" line and folks can tap in at a future date. Trustee Miley asked if it really was a 2" line. There will be 17 lots and there is 9 acres that the owner will keep and there is 8 acres not developable. The owners have been working with EPA, County, GHG and doing their homework. They will have a berm and fencing across the front. The height of the berm was a concern of the Zoning Commission and we want to maintain a rural/country feel. The county is pushing for a extension of the CAD to tie-in to 3 B's & K.Road proposed is 24' wide and better than Oxford Wood. They don't want to put a sidewalk in and county wants them to put them in since it is more than 15 homes. Each lot has building loaded and septic systems and has primary and secondary on there. Road frontage is appropriate. They want to have an HOA and the creek will all remain wooded with some type of walking path. The developer/contractor want to talk to Trustees at their next meeting.

ZI Lisano hasn't made progress on other items with property on 521 and signs or billboards or Mr. Rupp and Veatch Complaint.

Trustee Skinner made a motion to approve the June 13, 2023 agenda as amended. Trustee Stegner seconded. Motion passed.

Trustee Skinner made a motion to approve the May 9, 2023 regular meeting minutes and May 9, 2023 special meeting minutes as presented. Trustee Stegner seconded. Motion passed. Trustee Skinner made a motion to approve the May 11, 2023 special meeting minutes as presented. Trustee Miley seconded. Motion passed.

#### Fiscal Officer's Report:

Current First Commonwealth Checking Account Balance \$457,573.66 and earned \$7.90 in interest. Current STAROhio Account Balance \$1,388,023.35 interest and earned \$6,100.37 in interest. Ms. Link shared an updated trash voucher spreadsheet and noted that there were 4 instances where folks went over the maximum tonnage allowable per the program. Fiscal Officer Link will be notifying these individuals and in the future they will have to pay the overage. Fiscal Officer Link shared vacation plans for this summer.

Trustees reviewed and approved the bank reconciliation and timesheets for May 2023. Motion made by Trustee Skinner to release Warrants #21157-21177 \$9,474.02. Trustee Miley seconded. Motion passed.

Doug Reidel was not present. No updates.

#### **Zoning Inspector:**

Zoning Inspector Lisano went over his report. Updating landscaping and then solar resolutions. County prosecutors are not going to do anything related to solar. We can if we want. 1621 Hogback Road did not build according to permit. Further review will need to occur with several entities including a variance. Mr. Shellhouse (Baker Road from 36 (first property on left). He wants to put up a couple of agriculture structures and bring animals in from another property. Trustees were ok with ag permit. Zoning Inspector Lisano will be gore June 15th through June 26th.

Robert Johnson (owner) Beachwood Estates Development and attended the meeting. He is the owner of the property. Plans have been submitted to the Regional Planning Commission. Will bring water down from 3B's and K and extend it to the west (blue lines). Adding several fire hydrants along SR 521 and discussed with fire chief. Dividing up into minimum of 2 acre lots per zoning code. We had soil borings completed and testing of sanitary systems. They wanted to face the lots toward the north side and shot down by ODOT and they were not allowed to do that. Sites had to face road they were on. Originally had cul-de-sac toward center of property and they want future connection to the east. Agreed to bring it to within 100 feet of property line and within Mr. Akers and Rogers property. Sidewalks are required.

Have variance to request exemption of sidewalks. Easement that runs through for power line and trying to keep cul-de-sac out of that. Final engineering is being worked on. This road will be more substantial than Oxford Woods. Pavement will be 3" thicker and more piping for drainage than Oxford Woods. Mr. Johnson will be building his personal home next to the subdivision and drive facing SR 521. No turn lane needed. ODOT wanted him to fix the ditching problem and he is going to try to solve some of it. It's a busted drain tile. Walking trail is planned along with HOA. Final design in July and lots platted and then by fall maybe trees can be taken out and roads put in early spring. Raised area along SR 521. 6" water line and fire hydrants along the drive.

#### Road Superintendent:

Tree prices — called Hoover and King Tree service. Talked with Timberland again and prices. \$7500 The ones right at the end of the road (Howard) and the big one at green mound. Wade has no extra money to pay half. We don't own any on road right-a-way. It is even with the fence. Trustee Stegner made a motion to approve \$300 for Howard Road, \$2950 to have 2 trees at BTH removed and trim GMC tree for a cost not to exceed \$4,600. Trustee Skinner seconded. Discussion continued and clarifying some of the other proposals. Concerns about the cemetery stones. All approved.

If I get resident permission does she need to work with us on the location of the mirror and can it go on the sign or what. Trustees said it has to be on private property. They want the mirror to point down County Home Road. County Home Road is a county road is sue. A mirror isn't going to do much good on Cackler Road because it has to be cut of road right-a-way.

#### Fire Department:

Asphalt put behind building and the in front and then place flag pole. Final cleaning and painting inside being done. Just about done.

# Minutes of Brown Township Trustees Meeting

#### Held June 28, 2023

The Brown Township Trustees met on this date at 4:00 PM in special form with Trustees Miley, Skinner, and Stegner, Fiscal Officer Link, Road Superintendent Gladman and Guest Chuck Busch from MS Consultants

Trustee Miley called the meeting to order at 4pm on 6/28/2023

Chuck Busch with MS Consultants wanted to get a general idea of what we had in mind for a new maintenance facility on our two-acre property off Old State Road near Mulberry street.

Chuck stated that we will most likely need to do a site survey for grade and to figure the best way to lay out the building. Trustees discussed possible entrance to building off Mulberry street and also off of Old State Road. Also discussed an area for overflow parking. Drive and parking area to be gravel. Trustees discussed needing a 60 by 100-foot building with 4 bays. One bay possibly a wash bay. Also need an office or two, a bathroom, a locker/kitchenette area, plus storage. This could be a pole building type building with a porch at the walk-in door entrance. Will most likely need a soil scientist to help plan for storm water management, drainage, and leach field area. Further discussion about the building included needing an exhaust fan system, trench drains, and using metal to finish the inside ceiling of building. Also discussed an area for future salt storage. The next two phases of this process include design development and contract documents. Chuck Busch will begin a site plan and will hold a meeting again once he has a proposal, hopefully by our July meeting.

Trustee Miley moved to adjourn the meeting, Trustee Skinner second the motion. Motion passed. Meeting adjourned at 5:30pm.
