DATE, TIME, AND PLACE FOR THE VIEW AND PUBLIC HEARING FOR THE CONSIDERATION OF THE DRAINAGE IMPROVEMENT PETITION (2024) FOR FELKNER #302 WATERSHED, FILED BY CALVIN FINKS

Notice is hereby given that the Delaware County Board of Commissioners received a petition signed by Calvin Finks, to generally for the improvement/correction of drainage, both surface and subsurface, to a good and sufficient outlet by replacing, repairing, or altering the existing systems as required and/or creating new surface and subsurface drainage mains or laterals, as requested by this petition. There are currently tile "blow-outs"/breaks on the Calvin Finks and Trevor Vining properties that are visible. Multiple repairs have been done on the Calvin Finks property. We suspect that the existing tile is plugged close to Newhouse Road due to tree roots. Discussions with adjacent property owners for access to complete repairs have been unsuccessful. In Delaware County, Scioto Township, within the Felkner #302, watershed and generally following, but not limited to, the course and termini of existing improvements.

Notice is hereby given that the Board will conduct a view of the proposed improvement, with the County Engineer presenting an overview of the proposed improvement through the use of video technology, on Monday June 3, 2024, at 10:00A.M., at the Office of the Board of County Commissioners, 91 North Sandusky Street Delaware, Ohio.

Notice is hereby given that the Board will conduct the first hearing on the proposed improvement on Monday August 5, 2024, at 10:00A.M., at the Office of the Board of County Commissioners, 91 North Sandusky Street Delaware, Ohio.

If the petition is approved, all costs of engineering, construction and future maintenance will be assessed to the benefiting parcels of land.

Any owner may comment on the proposed improvement in writing before or in person at the public hearings on the petition.
