# Minutes of Brown Township Trustees Meeting

# Held May 13, 2025

The Brown Township Trustees met on this date at 6:00 PM in regular form with Trustees Miley, Stegner and Skinner, Fiscal Officer Barrett, Road Superintendent Dan Gladman, Zoning Inspector Steve Scerio and Guests Wilma Frost, Mark Frost, Teresa Gladden.

Trustee Skinner made a motion to approve the April 8, 2025 agenda as amended. Trustee Miley seconded. Motion passed.

Trustee Skinner led the Pledge of Allegiance

Trustee Miley made a motion to approve the May 13, 2025 regular meeting minutes as presented. Trustee Skinner seconded. Motion passed.

## Fiscal Officer's Report:

Current First Commonwealth Checking Account Balance \$336,301.81 and accrued interest of \$1,004.66 Current STAROhio Account Balance \$1,533,528.68 and earned \$15,619.51 in interest. Trustees reviewed and approved the bank reconciliation and timesheets for April 2025. Trustee Skinner made a motion to release Warrants #21568-21580 \$14,496.30. Trustee Stegner seconded. Motion passed.

Mrs. Barrett shared that there is a correction to the April 2025 meeting minutes; April warrants 21531-21567 \$13,575.16. She also shared she has issued 58 trash vouchers. Mrs. Barrett shared her vacation and summer schedule so trustees and employees would be aware and can plan appropriately. Fiscal Officer Barrett shared an email with employees with a cyber training link that needs to be completed by all employees and reported back once completed.

#### **Delaware County Engineer:**

Mr. Riedel stated that patching on Kelly McMaster Road is being looked into and an estimate will be provided. Pittman Road culvert repairs are scheduled for June, and Howard Road repairs scheduled for mid July, weather permitting. The repairs at North Old State Road should be completed next week, there was delay due to weather. The south section of North Old state will be starting soon.

# **Road Superintendent:**

Superintendent Gladman went over his report.

#### Roads:

Mr. Gladman stated the F450 advance Trac needs to be serviced by Byers Ford. The Ford dealership stated there is a problem with either someone driving the truck with their foot on the brake or that the trailer plug was wired incorrectly by The Dexter Company. The Dexter Company was contacted regarding the error and stated this could either be repaired at the Ford dealership and the invoice forwarded to them or they can fix the error.

Trustee Miley made the motion for the F450 truck to be repaired at the Ford dealership and the invoice sent to The Dexter Company; Trustee Skinner seconded the motion. There is a field tile blown out in the Northwest corn of the 6 acre park. This will repair will be looked at by Road Superintendent Gladman and Trustee Stegner.

#### Cemetery:

Cemetery foundations were poured by Longstretch and the invoices sent to the funeral homes for payment.

## **Fire Department:**

In April there were 49 runs, Troy Township had the most. Fire Academy trailer search and rescue was completed and over 100 people went through the trailer. If a dive team is kept at the fire department there will be a \$60,000 charge,, due to upgraded equipment and training being required. Next month there will be someone on duty 24 hours per day. In Mid-October the fire department will be hosting an open house.

The new maintenance garage is pending the AEP electric hook up and the final county inspections.
