Minutes of Brown Township Trustees Meeting

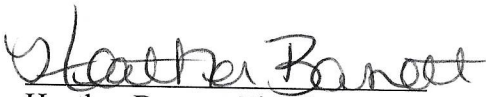
	Held October 30, 2025	
	The Brown Township Trustees met on this date at 5:44 pm in an emergency meeting form with Trustee Skinner and Trustee Miley. Fiscal Officer Barrett presented adding an appropriation Fund Capital Outlay Mis. Permanent Improvement 4301-760-700-0000 (this fund meets the revised code 5705.10 paragraph F). With an initial deposit of \$220,388.00 for the sale of 3785 N. Old State Road (old maintenance building) and increase the total for 2025 Township appropriation resolution to an amount of \$2,454,620.70. Trustee Skinner made a motion to approve to establish the adding an appropriation Fund, Capital Outlay – Mis. Permanent Improvement 4301-760-700-0000 (this fund meets the revised code 5705.10 paragraph F). With an initial deposit of \$220,388.00 for the sale of 3785 N. 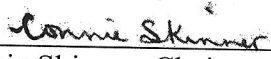
