## NOTICE

### REVISED DATE, TIME, AND PLACE FOR THE FINAL PUBLIC HEARING FOR THE CONSIDERATION OF THE JAMES JOINT COUNTY WATERSHED DRAINAGE IMPROVEMENT PROJECT

Notice is hereby given that the Delaware County Engineer has filed with the Clerk of the Delaware County Board of County Commissioners the plans, reports, and schedules for the proposed improvement (maintenance assessment) of the drainage improvement known as the James Joint County Watershed Drainage Improvement Project. The purpose of the project is to generally improve the drainage, both surface and subsurface, to good and sufficient outlet, by replacing, repairing or altering the existing improvements as required and/or creating new surface and subsurface drainage mains or laterals as requested, by this petition, in Delaware County, Marlboro Township and Marion County, Waldo Township, within the James Joint County Watershed and generally following, but not limited to, the course and termini of the existing improvement.

Notice is hereby given that the Joint Board of Commissioners of Delaware County, Ohio and Marion County, Ohio will conduct the final hearing on the report of the County Engineer, and on the proceedings for the improvement (maintenance assessment), on Monday, October 6, 2025, at 1:30P.M., at the Office of the Board of County Commissioners, 91 North Sandusky Street, Delaware, Ohio. The Joint Board shall also hear any evidence offered by any owner for or against the granting of the proposed improvement at this hearing.

If the petition is approved, all costs of engineering, construction and future maintenance will be assessed to the benefiting parcels of land.

Plans, reports, and schedules for the proposed improvements may be examined at the Delaware Soil and Water Conservation District, Resource Conservation Program at the Byxbe Building, 1610 State Route 521, Delaware, OH 43015 or call 740-368-1921.
