WHEREAS, the Ohio General Assembly has passed laws in the past requiring counties to pay certain costs for the defense of indigent defendants in local courts; and

WHEREAS, Ohio's public defender law originally provided that 50% of he costs would be paid by the county and 50% would be paid by the state; and

WHEREAS, the law was changed so that counties must pay more than 50% if the General Assembly does not appropriate adequate funds to pay for one-half of the costs of indigent defense services, and

WHEREAS, the result is that Delaware County has regularly paid more than half of the total costs in recent years which is an unfunded mandate on the county and local taxpayers, and

WHEREAS, Delaware County has been required since the early 1900's to pay for the office space and related costs of County Boards of Education, which are now known as Educational Service Centers; and

WHEREAS, county government is not involved in public education which is a function of the state and local school districts; and

WHEREAS, Delaware County has no control over the budget, staffing, operation, and facility needs of Education Service Centers and their services benefit local school districts, and

WHEREAS, the requirement in state law is an outdated and unfair unfunded mandate on Delaware County.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF DELAWARE COUNTY:

- 1. That the Ohio General Assembly should change the law to assure that counties are guaranteed 50% reimbursements for constitutionally mandated public defender services for indigent defendants.
- 2. That the Ohio General Assembly should change the law enacted in the early 1900's that requires the county to pay for office space related costs for Educational Service Centers.
- 3. That both of these issues should be addressed as a part of the next state biennial budget.

Fairgrounds by acquiring and constructing multi-purpose facilities, show arenas, junior fair complex, and other facilities and improvements, and furnishing and equipping the same, and that it is necessary that a direct tax be annually levied on all the taxable property in the County outside of the ten mill limitation to meet the debt charges on the Bonds and any securities issued in anticipation thereof,

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Delaware, Ohio, (the "County") that:

Section 1. It is necessary to proceed with the issuance of the Bonds in the amount and for the purpose described in the preamble to this resolution, and to levy, outside of the ten mill limitation provided by law, an annual tax on all the taxable property in the County to pay debt charges on the Bonds and any securities issued in anticipation thereof.

Section 2. The Bonds shall be dated approximately the 1st day of June, 1999; shall bear interest at the estimated rate of five and one-quarter per centum (5.25%) per annum; and shall be paid over a number of years not to exceed twenty-five.

Section 3. The question of issuing the Bonds shall be submitted to the electors of the County at the Election to be held at the usual voting places within the County, on the 4TH day of May, 1999.

Section 4. The form of the ballot to be used at said Election shall be substantially as follows:

A MAJORITY AFFIRMATIVE VOTE IS NECESSARY FOR PASSAGE

Shall bonds be issued by the County of Delaware, Ohio for the purpose of renovating and improving the Delaware County Fairgrounds by acquiring and constructing multi-purpose facilities, show arenas, junior fair complex, and other facilities and improvements, and furnishing and equipping the same in the principal amount of \$24,278,000 to be repaid annually over a maximum period of twenty-five (25) years and an annual levy of property taxes be made outside of the ten mill limitation estimated by the County Auditor to average over the repayment period of the bond issue .66 mills for each one dollar of tax valuation which amounts to seven (\$0.07) cents for each one hundred dollars of tax valuation, to pay the annual debt charges on the bonds, and to pay debt charges on any notes issued in anticipation of those bonds.
