### PUBLIC COMMENT

Mr. Jim Petro, Auditor of the State of Ohio, was in attendance to present Mr. Jon M. Peterson with an award honoring him for the high level of financial reporting at Delaware County that was initiated during his tenure as Delaware County Auditor. Mr. Petro explained the award he is presenting is the "Auditors" award and is to recognize those that achieve this high level of financial reporting. He explained that there is only a small percentage of units of government in the State of Ohio who achieve this high level of financial reporting excellence.

After receiving the award, State Representative Peterson then recognized Dave Cannon and Jane Tinker for their contribution to the process that is being recognized by this award.

Mr. Dave Staley, Chairman of the Board of Elections, spoke requesting that the Commissioners modify the current policy of sick leave pay out when an employee retires from the County. Kay Gordon recently retired due to a physical disability. Her disability retirement has been approved by the PERS retirement system. Mr. Staley argued this situation is different than when an employee reaches retirement age and retires by choice. Ms. Gordon is being forced to retire due to her health. She truly is ill and if she had chose, she could have remained on the payroll and used her sick time at the full rate of pay. Mr. Staley and the Board of Elections are requesting that her accumulated sick time be paid out at the rate of 50%. He added some departments in the County currently pay out sick leave at retirement at 50%.

Mr. Wuertz explained to Mr. Staley, that each elected official can set their own policies in areas such as this. The Commissioners have a policy that is applicable to any department that receives more than one half of their funding from the general funds of the County. Other elected officials do have different policies than those of the Commissioners. The Commissioners will address this issue at the next meeting when all three will be in attendance

Planning Commission and the Delaware County Engineer. Drainage improvements related to this subdivision have been constructed (or are bonded and will be constructed within a period of one year as evidenced by the Subdivider's agreement Exhibit "B" available at the County Engineer's Office). In accordance with Section 6137 of the Ohio Revised Code, we (I) hereby request that the improvements delineated on Exhibit "C" (available at the County Engineer's Office), be accepted as part of the County Ditch Maintenance Program and that an annual maintenance assessment be collected with the Real Estate Taxes for each lot in the subject subdivision to cover the cost of current and future maintenance of the improvements.

We (I) represent 100% of the property owners to be assessed for maintenance related to this drainage improvement.

We (I) hereby waive our rights to a public viewing and hearing and ask that your board approve this action in conjunction with the approval of the Sherbrook, Phase 6 Subdivision.

The cost of the drainage improvements is \$114,242.62 and a detailed cost estimate is available at the County Engineer's office in Exhibit "D". The drainage improvements are being constructed for the benefit of the lots being created in this subdivision. Sixty lots are created in this plat and each lot receives an equal share of the benefit (cost) of the project. The basis for calculating the assessment for each lot is therefore, \$1,904.04 per lot. An annual maintenance fee equal to 2% of this basis \$38.08 will be collected for each lot. I understand that the basis for calculating the maintenance assessment will be reviewed and possibly revised every 6 years. The first year's assessment for all of the lots in the amount of \$2,284.85 has been paid to Delaware County.
