Procedures				

I. Purpose: To Provide General Guidelines Of The Rules And Regulations That Govern The Driving Procedures For Medic Vehicles In Response To A Request For Assistance. These Guidelines Are Not All Inclusive. If A Crew Is In A Situation Not Governed Specifically By These Rules, They Must Exercise Extreme Caution And Common Sense In Their Response. They Must Operate At All Times To Ensure The Safety Of Their Crew, The Public, Other Responders And Their Vehicle.

### II. Definition Of Terms:

- A. Emergency As Defined By The Ohio Revised Code, An Emergency Is The "Immediate Threat To Life".
- B. Non-Emergency All Other Medical Responses
- C. Medic Vehicle Ems Operated Vehicles Equipped With Emergency Lighting, Sirens, Medical Equipment, Etc. That Are Exempt From Normal Classification By The Ohio Revised Code.

D. Dispatch – Alerting Units Via Tones, Wireless Radio, Or Other Communication Means That An Ems Response Is Required

## III. Driving Procedures:

#### A. General -

- 1) Respond Using The Quickest And Safest Route. Personnel Will Utilize Geographical Knowledge Of Roadways, Available Maps, Dispatched Cross-Streets Or Query Central For Directions.
- 2) The Driver Will Always Consider Appropriate Driving Conditions, Such As Weather, Visibility, Traffic Flow, Etc.
- 3) Drivers Will Not Operate Emergency Equipment (Lights, Siren, Etc.) When Another Crewmember Can Assume This Responsibility.
- 4) Excessive Speed Increases The Severity Of A Collision. Speed Increases Stopping Distance And So Reduces The Chance Of Avoiding A Hazardous Situation.
- 5) Medics Will Normally Be Dispatched Through The Delaware County Emergency Communications Center (Central) Upon Receipt Of A 9-1-1 Telephone Call Or A Request For Service By Another Public Safety Entity Or Citizen.
- 6) Medics May Also Place Themselves In-Service Status For A Response Due To Emergency Medical "Walk-Ins" At The Medic Station. The Medic Crew Must Advise Central Of The Nature And Location Of The Incident Prior To Leaving The Station.
- 7) When Driving Left Of Center, Against Right Of Ways, Or Through Intersections, Additional Caution Must Be Exercised.
- 8) When Approaching An Intersection, Be Alert To Sudden Moves By Other Drivers. Do Not Go Through An Intersection Before Coming To A Near Stop To Assure Safety In Proceeding.
- 9) At All Times The Driver Must Drive In A Manner That Maintains Control Of The Vehicle And Assures The Safety Of His/Her Crew And Those Sharing The Roadway.
- 10) When Backing The Vehicle Into Any Area Or Building There Will Be A Designated Spotter Behind The Vehicle To Ensure The Safety Of Bystanders And To Ensure The Vehicle Is Not Damaged Or Causes Damage To Another Structure. Exceptions Will Be Rare, But May Be Made When Placing A Member Outside The Vehicle Exposes Them To Personal Injury From Traffic Or Other Hazards. If A Driver Backs A Vehicle Without A Backer, He/She Will Be Held Responsible For Any Resulting Accident Or Damages!
- 11) The Crew Chief Will Not Drive The Vehicle To The Response Location Or In Transport Of A Patient Unless Absolutely Necessary Due To Manning Or Other Circumstances That Might Preclude Other Crew Members From Driving. Crew Chiefs Or Senior Personnel Will Be Responsible For Ensuring That Drivers Follow Established Procedures And Exercise Due Regard.
- 12) Only The Primary Medic Unit Will Respond In An Emergency Mode, I.E. With "Lights And Siren". Second Units In Will Respond At Posted Speed Limits Unless Advised By The Medic On-Scene To "Step-Up" Their Response. All Responding Units Will Exercise "Due Regard".

## B. Specific Rules And Recommendations:

- 1. Emergency Lights And Sirens Are Required On All Emergency Responses And When Requesting The Right Of Way. Emergency Lights And Sirens Only Request The Right Of Way. Never Assume That All Motorists Hear Your Signal! Failure To Use Lights And Sirens While On An Emergency Run Will Result In Disciplinary Action, Up To And Including Possible Termination.
- 2. The Driver Shall Always Operate The Vehicle With Caution In Due Regard For The Safety Of Others Operating On The Highways. Any Employee Found Driving Without Due Regard Will Be Subject To Discipline, Up To And Including Termination. Employees Observing Unsafe Driving Habits Or Occurrences By Personnel Shall Report The Situation To The Duty Supervisor. Personnel Found Driving In An Unsafe Manner Or Without Due Regard Will Also

Be Subject To A Suspension Of Their Driving Privileges And A Requirement To Attend Further Driver Training.

- 3. Drivers Will Always Drive At The Posted Speed Limit In School Zones During Restricted Hours And Be Alert For Sudden Movement By Children Or Adults.
- 4. Due To The Size, Weight And Lack Of Maneuverability Of A Medic Vehicle, It Is Strongly Recommended That Drivers Not Exceed 65 M.P.H. On The Open Highway And Not Exceed The Posted Speed Limit By More Than 10mph Inside Village And Municipal Limits As Well As Known Congested Traffic Areas.
