It was moved by Mrs. Martin, seconded by Mr. Wuertz to approve the Agreement.

LISW Agreement

The Board of Commissioners of Delaware County, Ohio ("County"), <u>Rose Powers (</u>"Employee") and <u>Ms. Sherene</u> <u>Gardner</u> ("Contractor"), in consideration of the mutual covenants, agreements, and stipulations set forth herein, and pursuant to the laws of the State of Ohio and the United States, hereby agree as follows:

In order to become a Licensed Independent Social Worker (LISW) under the requirements of the State of Ohio Counsel and Social Worker Board, a social worker must be supervised by a professional LISW for a period of twenty-four (24) months. County currently does not employ an LISW who could fulfill this supervision requirement.

1. County will allow the cost of the supervision of Employee by Contractor to qualify for reimbursement under the rules and guidelines of the currently adopted Tuition Assistance Program subject to the following modifications

1.County waives 5.0(A)(6) and 5.0(A)(7) of the Tuition Assistance Policy and substitutes the following:

A. County will pay for the cost of the services of Contractor at \$50 per hour, up to a maximum of \$3,000 per calendar year, directly to Employee after receiving a status report each January 15, April 15, July 15, and October 15 with the signature and seal of Contractor showing that Employee is successfully progressing toward completion of the program within the twenty-four (24) month time period. Employee shall show proof of payment in the form of a written receipt from Contractor or a canceled check prior to submitting for reimbursement from County. B. Employee will be responsible for making payment directly to Contractor for the services of Contractor.

2. County waives section 5.0(B)(1), 5.0(B)(4), 5.0(B)(5), and 5.0(E)(1) of the Tuition Assistance Policy. Contractor agrees to supervise Employee for a period of twenty-four (24) months and to provide a status report with an invoice for services to Employee each January 15, April 15, July 15, and October 15 with a signature and seal of Contractor.

3. Employee agrees to:

Perform all the duties and requirements of Employee's position with Delaware County and to maintain progress towards the attainment of the licensed independent social worker (LISW) status;

Abide by this Agreement and the rules and guidelines of the current Tuition Assistance Program, with substitutions and exceptions noted under part 1 of this Agreement;

Forward the original invoice for services rendered by Contractor, proof of payment to Contractor in the form of a written receipt or a canceled check, and the original status report submitted by Contractor to County immediately upon receipt; and

Provide payment for services rendered to Contractor within thirty (30) days of receiving the invoice for those services from Contractor.

4. Employee and Contractor agree to hold the County free and harmless from any and all claims for damages and any nature arising out of or related to the acts or omissions of Employee and/or Contractor, and their employees or agents, under this Agreement.

5. Any of the parties may terminate this Agreement at any time upon sixty (60) days written notice. Contractor may terminate this Agreement for non-payment of fees with thirty (30) days written notice. County's obligation to pay for supervision terminates after 24 months whether or not Employee has attained the LISW status.

6. This Agreement does not create an employer/employee relationship between County and Contractor. Contractor is an independent contractor, and not an employee of County. Contractor is responsible for all taxes, workers compensation, and unemployment insurance that may arise as a result of this Agreement.
