WHEREAS, Ben Curtis is a 1996 graduate of Buckeye Valley High School, where he won three Central District Titles and two state titles, after which he proceeded to win two Ohio Amateur Championships and was a U.S. Amateur semifinalist in 1999, and

WHEREAS, Ben Curtis was ranked 396<sup>th</sup> in the world prior to the British Open, and

WHEREAS, Ben Curtis stunningly climbed to the top, defeating the world's best golfers - Sergio Garcia, Davis Love III, Kenny Perry, Vijay Singh, Tiger Woods- and won the 132<sup>nd</sup> British Open and the Claret Jug, and

WHEREAS, Ben Curtis is the first player to win in his first attempt at a major golf championship in 90 years, and is just the 6<sup>th</sup> player since 1900 to win the British Open in his first attempt, and
