### Blue Church Road Over Little Walnut Creek Bid Opening of 4/28/03

As a result of the referenced bid opening, all bids submitted were higher than the allowable 10% over the approved cost estimate for this project. The Engineer feels that, after reviewing prices of materials and labor of the bidders, the original estimate was much lower than current industry pricing. The Engineer has, therefore, revised the cost estimate for this project to reflect more accurate pricing. This estimate is \$209,000.00. A copy is available for review in the Commissioners Office.

The Engineer would like to re-bid this project with the new bid opening date of May 19, 2003.

#### **INVITATION TO BID**

Sealed proposals will be received at the **Delaware County Engineer's Office, 50 Channing Street, Delaware, Ohio 43015 until 10:15 a.m. local time on Monday, May 19, 2003** for furnishing all labor, materials and equipment necessary to complete the project known as

and at said time and place, publicly opened and read aloud. Contract documents, bid sheets, plans, and specifications can be **picked up** at the **Delaware County Engineer's Office**, **50 Channing St. Delaware**, **Ohio 43015** at NO COST for plans and specifications (11"x17" plan copies only). Bidders must make arrangements to obtain the bid packet; they will not be mailed.

This is the second bidding of this project since all previous bids submitted April 28, 2003 were over 10% above the Engineer's estimate. The revised estimate is not being published.

Each bidder is required to furnish with its proposal a Bid Guaranty and Contract Bond in accordance with Section 154.54 of the Ohio Revised Code. Bid Security furnished in Bond form shall be issued by a Surety Company or corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity, and a complete listing of all subcontractors to be used. The owners intend and require that this project be completed no later than August 15, 2003.

Bidders must comply with the Prevailing Wage Rates on Public Improvements in Delaware County as determined by the Ohio Bureau of Employment Services, Wage and Hour Division.

The Delaware County Engineer's Office reserves the right to waive irregularities and to reject any or all bids.

#### Scope of Work

This project consists of the replacement of an existing 13' span steel beam bridge on Blue Church Road over Little Walnut Creek in Kingston Township, Delaware County, Ohio. The bridge is located about 0.1 miles north of S.R. 521.

The proposed structure is a 20' span precast concrete arch culvert (Con/Span) on spread footings. The project will also include approach realignment, widening and paving for approximately 200 feet to the south of the bridge and 410 feet to the north. Guardrail and shoulder grading shall also be performed. Minor drainage improvements including installation of an enclosed ditch system shall also be a part of this work.
