Whereas, The Delaware-Morrow Mental Health & Recovery Services Board will be the applicant and fiscal agent of the grant and will provide the matching funds for the Grant, and

Whereas, the County Commissioners recognize the need for additional services to families and youth with substance abuse and behavioral health needs,

Program Overview

"Alternative Avenues for Youth" is an intensive outpatient services (IOS) approach to treat youths suffering from substance abuse and behavioral/emotional problems.

The program is built upon The Integrated Dual Disorders Treatment (IDDT) model, an evidence-based program which was created to offer an integrated treatment model for persons with co-occurring substance abuse and mental illness to address the needs of the whole person in the context of strong community social supports.

The program implements the mental health court docket that has recently been approved by a planning team of mental health providers, the Delaware County Courts, probation officers, case managers and juvenile specialists.

Participants commit to 4-6 hours per week, which results in four days of treatment per week. The average length of the program will vary based on the individual, but it is estimated at an average of 18 months.

Services include a psycho-educational component, intensive outpatient therapy services, and aftercare. The psycho-educational phase includes Moral Reconation Therapy (MRT) for youths, a cognitivebehavioral counseling program that fosters moral development in treatment-resistant clients. Families play an important part in this program, and parents will participate in "Parent Project," a parenting skills program designed specifically for parents of adolescents described as oppositional defiant or conduct disordered.

The other major piece of the "Alternative Avenues for Youth" program is the intensive outpatient therapy. Therapy will take many forms over an average 18 month time period. As the next phase will outline in more detail, therapy sessions will be one-on-one, group, family counseling, as well as gender-specific, primarily to address specific needs of girls vs. boys.

Once the formal program is completed, an ongoing after-care component is added to help participants ease back into a substance-free lifestyle and positive emotional outlook.
