IN THE MATTER OF APPROVING CHANGES TO THE DELAWARE COUNTY DEPARTMENT OF JOB AND FAMILY SERVICES PREVENTION, RETENTION, CONTINGENCY PROGRAM:

Proposed Changes to the PRC Plan to be in Effect March 3, 2006

- Assistance through Employment Related Services is limited to \$500 within a 12 month period of eligibility.
- The Financial Eligibility Standard for Employment Related Services will be 185% of the Federal Poverty Guideline.
- The additional monetary assistance up to \$1,500 available for requests of education/training assistance will be terminated.
- Assistance through Financial Crisis will be limited to \$500 within a 12 month period of eligibility.

- The Financial Eligibility Standard for Financial Crisis PRC will be 150% of the Federal Poverty Guideline.
- There will no longer be an increased eligibility standard of 200% FPL for assistance with heating expenses in connection with HEAP applications.
- A section has been added to the plan. It is called the Smart Parents Guide to Raising Middle School Aged Children. It is a training program for parents and middle school aged children that assists parents who are overwhelmed by the increasing pressures and responsibilities of raising preadolescent children. The sessions will provide the parents with the support and skills needed to ensure their success in keeping their families together. Sessions will be offered to children to help them understand adolescence. Parents and children will improve skills in communication, understanding and problem solving. Through improved communication, youth may be diverted from risky behavior such as out of wedlock pregnancies, legal and emotional problems and academic challenges.
