assessment be collected with the Real Estate Taxes for each lot in the subject subdivision to cover the cost of current and future maintenance of the improvements.

We (I) represent 100% of the property owners to be assessed for maintenance related to this drainage improvement. We (I) hereby waive our rights to a public viewing and hearing and ask that your board approve this action in conjunction with the approval of the **Olentangy Crossings Section 7 Plat**.

The cost of the drainage improvements is \$56,088.00 and a detailed cost estimate is available at the County Engineer's office in Exhibit "D". The drainage improvements are being constructed for the benefit of the lots being created in this development. The Developed multi-family area totaling 158 units (36.109 acres) and the developed commercial area totaling 1 unit (1.039 acres) will receive benefit (cost) of the project on a per unit basis. The basis for calculating the assessment for each unit is therefore, \$352.75 per unit. An annual maintenance fee equal to 2% of this basis \$7.06/unit will be collected for each tributary unit within **Olentangy Crossings Section 7**.

I understand that the basis for calculating the maintenance assessment will be reviewed and possibly revised every 6 years. The first year's assessment for all of the lots in the amount of \$1,121.76 has been paid to Delaware County.

Easements to provide for the maintenance of the improvements have been provided on the plat.

We (Delaware County Bank and Trust and Planned Communities Inc) have provided the appropriate easements for the drainage maintenance. We hereby waive our rights to a public viewing and hearing and ask that your board approve this action.

The cost of the drainage improvements is \$14,229.00 and a detailed cost estimate is available at the County Engineer's office in Exhibit "D". The drainage improvements are being constructed for the benefit of the 0.483 acre commercial lot. An annual maintenance fee equal to 2% of this basis will be collected for this commercial lot. I understand that the basis for calculating the maintenance assessment will be reviewed and possibly revised every 6 years. The first year's assessment in the amount of \$286.00 has been paid to Delaware County. (\$143.00 by DCB&T and \$143.00 by PCI).

Easements to provide for the maintenance of the improvements have been provided on the plat.

The basis for calculating the assessment for each lot is therefore, \$5,331.25 per lot. An annual maintenance fee equal to 2% of this basis \$106.63 will be collected for each lot. I understand that the basis for calculating the maintenance assessment will be reviewed and possibly revised every 6 years. The first year's assessment for all of the lots in the amount of \$3,412.00 has been paid to

IN THE MATTER OF AUTHORIZING THE ACCEPTANCE AND AWARDING OF THE BID AND APPROVING THE CONTRACT SUBMITTED BY BEHELER EXCAVATING FOR THE CDBG FY'05 OSTRANDER FLOOD AND DRAINAGE PROJECT:

It was moved by Mr. Evans, seconded by Mr. Jordan to approve the following:

WHEREAS, the Ohio Department of Development provides financial assistance to local governments under the Community Development Block Grant (CDBG) Formula Program; and

WHEREAS, funding for the Ostrander Flood and Drainage Project in the amount of \$39,800 has been provided to Delaware County through the FY'05 CDBG Formula Program, and use of the Delaware County Revolving Loan Fund (RLF) in an amount up to \$5,000 has been approved by the Delaware County Board of Commissioners for additional funding for this project; and

WHEREAS, the project has gone out to bid, and the engineer for Ostrander has reviewed said bids received, and it has been determined that the bid submitted by Beheler Excavating, in the amount of \$44,788.40 is the lowest and best bid.

NOW THEREFORE, PURSUANT TO THE FOREGOING, BE IT HEREBY RESOLVED by the Board of Commissioners, County of Delaware, State of Ohio as follows:

Section 1. That the Delaware County Board of Commissioners awards the bid to Beheler Excavating to perform the Flood and Drainage Improvements associated with the Ostrander Flood and Drainage Project, as approved in the FY'05 CDBG Formula Grant.

Section 2. That the Delaware County Board of Commissioners agrees to fund this project up to an amount of \$39,800 from CDBG FY' 05 funds, and up to an amount of \$5,000 from the Delaware County Revolving Loan Fund.

Section 3. That this resolution shall take effect and be in force immediately after its passage.

ARTICLE 2. The Contract Price.

The Owner will pay the Contractor for the quantities of work performed at the unit prices stipulated in the Bid for the respective items of work completed for the sum of Forty-Four Thousand Seven Hundred Eighty-Eight and 40/00 (Dollars) \$44,788.40 subject to additions and deductions as provided in Section 109 of the Housing and Community Development Act 1964.

A RESOLUTION AUTHORIZING MODIFICATION OF AN ENTERPRISE ZONE AGREEMENT AND EXECUTION OF AN ENTERPRISE ZONE AMENDMENT AGREEMENT BETWEEN THE DELAWARE COUNTY BOARD OF COMMISSIONERS, EDUCATION SALES MANAGEMENT (ESM) AND THE ORANGE TOWNSHIP BOARD OF TRUSTEES FOR THE ESM CALL CENTER PROJECT:

It was moved by Mr. Jordan, seconded by Mr. Evans to approve the following:

WHEREAS, Orange Township and Delaware County have encouraged the development of real estate and the investment in personal property within a certain area of the township via the establishment of an Enterprise Zone Area; and

WHEREAS, on June 19, 2006, the Orange Township Board of Trustees passed Resolution 06-273, and on June 26, 2006 the Delaware County Board of Commissioners passed Resolution 06-833, authorizing the execution of an Enterprise Zone agreement with Education Sales Management (ESM); and

WHEREAS, the Delaware County Board of Commissioners, Orange Township, and ESM did enter into an Enterprise Zone Agreement dated June 26, 2006, in conjunction with a PROJECT to be undertaken by ESM to invest an estimated \$500,000 in new tangible personal property consisting of new machinery & equipment and furniture & fixtures, invest an estimated \$115,000 in new real property leasehold improvements for the purpose of renovating 7,000 -15,000 square feet to accommodate a new call center operations, and create 125 new full-time equivalent employment positions and an estimated \$5,200,000 new annual payroll as a result of new job creation at a site in Orange Township located at 8337 Green Meadows Drive, Lewis Center, Ohio (PROJECT site); and

WHEREAS, pursuant to said Enterprise Zone Agreement, ESM is the presumed investor in real property leasehold improvements and personal property and creators of new full-time equivalent (FTE) job opportunities and new annual payroll, and Sarcom Properties, Inc. is the owner of said PROJECT site; and

WHEREAS, said Enterprise Zone Agreement has been submitted to and has been filed by the Ohio Department of Development (ODOD), and ODOD has recommended that said property owner should be added as an additional Party to said Agreement, to assure that the approved exemptions on real property improvements resulting from ESM's leasehold improvements, are applied to the PROJECT site by the Delaware County Auditor and Ohio Department of Taxation as intended in the original Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners, County of Delaware, State of Ohio that said Board authorizes execution of an agreement amending the ESM Enterprise Zone Agreement dated June 26, 2006 as follows:

1. Sarcom Properties, Inc., as owner of the PROJECT site, is hereby added as a Party to the Enterprise Zone Agreement and agrees with and consents to all terms and conditions of such Enterprise Zone Agreement.
2. ESM shall remain entitled to and responsible for all duties, benefits, obligations, liabilities and commitments provided for ESM as stated in the original Enterprise Zone Agreement dated June 26, 2006. If ESM materially fails to fulfill their duties, obligations, and commitments under this Agreement, Delaware County and Orange Township may terminate or modify the exemptions from taxation granted to ESM under this agreement, and may require the repayment, from ESM, of the amount of taxes that would have been payable had the property not been exempted from taxation under this agreement.
3. Except as provided herein, the Enterprise Zone Agreement dated June 26, 2006 continues unchanged and in full force and effect.
4. Delaware County shall grant the real and tangible personal property tax exemption called for under the original Agreement for the referenced PROJECT in recognition of this modification.
5. The Delaware County Director of Economic Development is directed to formally notify the Olentangy Local School District, the Delaware Area Career Center, the Delaware County Auditor, the Ohio Department of Development, and the Ohio Department of Taxation in writing of this modification.
6. That this Resolution shall take effect and be in force immediately after its passage.
