Whereas, Statistics for 2004 Delaware County indicate that of the 58,665 returns filed, 23,995 or 40.9% of those filed were from the low income population, and

Whereas, only 4,227 returns were filed which included EITC, and

Whereas, the Community Action goal is to bring a heightened awareness of the federal dollars available to this population and the ultimate direct benefits to those needing this income the most, and

Whereas, guidelines for those filing this year include households making nearly \$40,000, married and with 2 children and single taxpayers with no children may file and receive a return if their income is less than \$11,000 for the year.
