IN THE MATTER OF RECOGNIZING THE MONTH OF MAY 2008 AS AMYOTROPHIC LATERAL SCLEROSIS AWARENESS MONTH IN DELAWARE COUNTY, OHIO:

Amyotrophic Lateral Sclerosis Awareness Month

WHEREAS, Amyotrophic lateral sclerosis or ALS is better known as Lou Gehrig's disease; and

WHEREAS, ALS is a fatal neurodegenerative disease characterized by degeneration of cell bodies of the lower motor neurons in the gray matter of the anterior horns of the spinal cord; and

WHEREAS, As ALS progresses the patient experiences difficulty in swallowing, talking, and breathing, and ALS eventually causes muscles to atrophy and the patient becomes a functional quadriplegic; and

WHEREAS, ALS does not affect a patient's mental capacity, so that the patient remains fully alert and aware

of his or her loss of motor functions and the inevitable outcome of continued deterioration and death; and

WHEREAS, ALS occurs in adulthood, most commonly between the ages of 40 to 70 years, with the peak age about 55 years, and affects men two to three times more often than women; and

WHEREAS, Over 5,000 ALS patients are diagnosed annually and an equal number perish; and

WHEREAS, Over 250,000 people alive today will succumb to ALS and multiples of that number will fall victim to its effects; and

WHEREAS, On average, patients diagnosed with ALS only survive two to five years from the time of diagnosis; and

WHEREAS, research indicates that military veterans are at a 50% or greater risk of developing ALS than those who have not served in the military; and

WHEREAS, ALS has no known cause, means of prevention, or cure; and

WHEREAS, Amyotrophic Lateral Sclerosis Awareness Month increases the public's awareness of ALS patients' circumstances and acknowledges the terrible impact this disease has not only on the patient but on his or her family as well, and recognizes the research being done to eradicate this horrible disease; now, therefore, be it

Resolved by the Board of Commissioners, Delaware County, Ohio, jointly, that the Body hereby proclaims the month of May 2008 as Amyotrophic Lateral Sclerosis Awareness Month in Delaware County, Ohio; and be it further

Resolved, it is critical to the struggle to defeat this terrible disease that the people and leaders of our community, and indeed our entire country, be educated and aware of the disease, as well as the issues confronting those who are affected by it. A paper entitled "ALS in the Military, Unexpected Consequences of Military Service" outlines that military veterans are at a 50% or greater risk of developing ALS than those that have not served in the military. It is only through increased awareness that elected officials, medical researchers and health care professionals will give ALS patients the attention that they need and deserve.

Resolved, that the Commissioners urge the citizens of the County to educate themselves further as to the tremendous challenges facing the victims, their families and the researchers attempting to defeat this insidious disease.

A RESOLUTION ESTABLISHING A COUNTY PUBLIC DEFENDER COMMISSION (AS AMENDED WITH RESOLUTION NO. 08-539):

The Board of County Commissioners of the County of Delaware, Ohio met in regular session on May 8,2008, at the Commissioners Hearing Room, 101 North Sandusky Street, Delaware, Ohio 43015, with the following members present:

Glenn A. Evans, Commissioner Kristopher W. Jordan, Commissioner James D. Ward, Commissioner

Commissioner Ward moved the adoption of the following resolution:

WHEREAS, pursuant to section 120.13(A) of the Revised Code, the county commissioners in any county may establish a county public defender commission; and

WHEREAS, in Resolution No. 05-1443, adopted on October 24, 2005, the Delaware County Board of Commissioners (the "Board") re-established a Delaware County Public Defender Commission; and

WHEREAS, no appointments were made to the commission created by Resolution No. 05-1443 and no date for establishment was set; and

WHEREAS, due to the increasing costs of the county's current appointed counsel system, the Board recommends considering an alternative form of providing legal representation to indigents in Delaware County; and

WHEREAS, the establishment of a county public defender commission is the proper body to consider alternative forms of providing legal representation to indigents in Delaware County;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, OHIO:

Section I. Pursuant to section 120.13(A) of the Revised Code, the Board hereby establishes the Delaware County Public Defender Commission (the "Commission"), which shall consist of five members, three of whom shall be appointed by the Board, and two by the presiding judge of the Court of Common Pleas of the Delaware County. At least one member appointed by each of these appointing bodies shall be an attorney admitted to the practice of law in this state.

Section II. The Commission shall be formally established, and the appointments of all members thereof shall take effect, on <u>May 8, 2008</u>. The Board hereby directs the Clerk of the Board to certify a copy of this Resolution to the Ohio Public Defender Commission, thereby notifying that body of the of the date of establishment.

Section III. In accordance with the requirements of sections 120.13(A) and (C), the Board shall, by separate Resolutions, make the following appointments to the Commission:

- (1) Two members who shall serve terms commencing on the date of establishment in Section II of this Resolution and expiring two years thereafter; and
- (2) One member who shall serve a term commencing on the date of establishment in Section II of this Resolution and expiring four years thereafter.
