# IN THE MATTER OF DELAWARE COUNTY COMMISSIONERS ENTERING INTO A JOINT COOPERATION AGREEMENT WITH THE CITY OF DELAWARE FOR THE NEIGHBORHOOD STABILIZATION PROGRAM:

It was moved by Mr. O'Brien, seconded by Mr. Hanks to approve the following:

WHEREAS, the Ohio Department of Development (ODOD) was awarded more than \$116.8 million of Neighborhood Stabilization Program (NSP) funds by the U. S. Department of Housing and Urban Development (HUD), and

WHEREAS, the Ohio Department of Development, Office of Housing and Community Partnerships (OHCP) is responsible for the administration of the NSP to local communities, and

WHEREAS, NSP funds are to help stabilize neighborhoods and impede the decline in vacant and foreclosed homes, and

WHEREAS, Delaware County and the City of Delaware are eligible to receive a total of NSP funds in the amount of \$1,136,655, which includes \$113,600 for administration, and

WHEREAS, in order to participate in the program, the communities had to select a lead unit of local government to administer the program; and

WHEREAS, Delaware County Commissioners on Resolution # 09-30 dated January 12, 2009, agreed to have

the City of Delaware be the lead unit of local government for the NSP funds, and

WHEREAS, Delaware County and the City of Delaware agrees to enter into a Joint Cooperation Agreement for the Neighborhood Stabilization Program.

NOW THEREFORE, PURSUANT TO THE FOREGOING, BE IT HEREBY RESOLVED by the Board of Commissioners, County of Delaware, State of Ohio as follows:

Section 1. The Board of Commissioners authorizes the President of the Board to sign the Joint Cooperation Agreement.

WHEREAS, the Congress of the United States has enacted the Housing and Economic Recovery Act of 2008 (Act) which has as its primary objective of improving neighborhoods by supporting the purchase and redevelopment of abandoned and foreclosed properties, establishing land banks, and demolishing blighted structures, and whereby federal assistance will be provided for the support of neighborhood stabilization the five eligible uses listed by HUD in the October 6, 2008 Federal Register Notice regarding the HERA of 2008, which are:

- (A) establish finance mechanisms or purchase and redevelopment of foreclosed upon homes and residential properties, including such mechanisms as soft-seconds, loan loss reserves, and shared-equity loans for low- and moderate-income homebuyers;
- (B) purchase and rehabilitate homes and residential properties that have been abandoned or foreclosed upon, in order to sell, rent, or redevelop such homes and properties;
- (C) establish land banks for homes that have been foreclosed upon;
- (D) demolish blighted structures; and
- (E) redevelop demolished or vacant properties.

WHEREAS, City of Delaware, Ohio has been designated as the Lead Community responsible for administering the grant provided from the State of Ohio Department of Development to implement project activities identified in Delaware County Neighborhood Stabilization Program (NSP), as a result of the enactment of Title III of Division B of the Housing and Economic Recovery Act of 2008 (HERA); and

**WHEREAS**, City of Delaware and Delaware County have been allocated one million one hundred thirty six thousand six hundred fifty five dollars (\$1,136,655) from the State of Ohio Neighborhood Stabilization Program funds; and

**WHEREAS**, City of Delaware, as the Lead Community is responsible for preparing the grant application in cooperation with its partner, Delaware County, including the selection of eligible project activities, and administering the grant in accordance with the NSP rules and regulations.

**NOW, THEREFORE**, City of Delaware and Delaware County hereby agree to the following terms of this Cooperation Agreement:

- City of Delaware and Delaware County agree to implement the NSP in compliance with Community Development Block Grant requirements as modified by the Housing Economic and Recovery Act of 2008 (HERA), the U.S. Department of Housing and Urban Development NSP Notice, the State of Ohio Amended Consolidated Plan, and the NSP application guidelines.
- 2. This Cooperating Agreement remains in effect until the NSP funds and program income received are expended and the funded activities completed and closed out, and that the Delaware County and the City of Delaware cannot terminate or withdraw from this Cooperating Agreement while it remains in effect.
- 3. City of Delaware and Delaware County are obligated to take all actions necessary to assure compliance with the certification required by Section 104(b) of Title I of the Housing and Community Development Act of 1974, as amended, including Title VI of the Civil Rights of 1964, the Fair Housing Act, Section 109 of the Housing and Community Development Act of 1974 and other applicable laws.
- 4. The City of Delaware and Delaware County agree that NSP funds are prohibited for activities in, or in support of, any cooperating unit of local government that does not

- affirmatively further fair housing within its own jurisdictions or that impedes actions to comply with its own fair housing certifications.
- 5. The City of Delaware agrees that it has a policy prohibiting the use of excessive force by law enforcement agencies within its jurisdiction against any individuals engaged in non-violent civil rights demonstrations.
- 6. The City of Delaware agrees that it has a policy of enforcing applicable State and local laws against physically barring entrance to or exit from a facility or location which is the subject of such non-violent civil rights demonstrations within jurisdictions.
- 7. This Cooperating Agreement does not contain a provision for veto or other restriction that would allow any party to obstruct the implementation of the NSP Program during the period covered by this agreement, which is April 1, 2009 to March 30, 2013.
- 8. The City of Delaware, Ohio agrees that pursuant to 24CFR 570.501 (b), if Delaware County undertakes assisted activities with NSP funds, that it is subject to the same requirements applicable to sub-recipient including the requirement of a written agreement as described in 24 CFR 579.503.

#### **Legal Form and Sufficiency**

This Cooperating Agreement has been reviewed by legal counsel of the City of Delaware and Delaware County Prosecutor, and it has been determined that the terms and conditions of said agreement are fully authorized under State and local law and that said agreement provides legal authority for the City of Delaware.
