## IN THE MATTER OF DECLARING THE INTENT OF THE DELAWARE COUNTY COMMISSIONERS TO PROCEED WITH THE BIDDING, INSTALLING AND OPERATING A FIBER OPTIC NETWORK:

It was moved by Mr. Hanks, seconded by Mr. Thompson to approve the following and it was agreed by Mr. Hanks and agreed by Mr. Thompson to include the amendment of the addition of line 6 to the originally presented resolution:

Whereas, the Delaware County Board of County Commissioners desire to promote public safety, business, education and efficiency for Delaware County governments, and

Whereas, there is a need for improved technology within Delaware County that improves communications and access to information, and

Whereas, fiber optic technology is now a necessity for all business and education to communicate and have access to information and share data, and

Whereas, Delaware County will be a leader in providing fiber optic technology throughout the County to attract businesses and improve the efficiency of government, business, and education by planning and providing a fiber optic network to be used by entities with a need for such technology, and

Whereas, fiber optic technology should be shared by the various jurisdictions within the County to the benefit of all cities, villages and townships for the betterment of all concerned

THEREFORE BE IT RESOLVED by the Board of Commissioners of Delaware County:

- 1. It is the intention of the Board of Delaware County Commissioners to move forward with bidding, installing, and operating a fiber optic network in Delaware County.
- 2. The Board of County Commissioners direct the County Administrator and Economic Development Director to represent the County in working with the County Prosecutor's Office, County Auditor's Office and the Data Center in support of completing such network with the planning, designing, bidding, constructing, installing and financing of a fiber optic network within the County.
- 3. The parties identified above shall work in conjunction with various entities within Delaware County to determine the best method in which this network shall be owned and operated to the benefit of all Delaware County entities.
- 4. Until such time as an ownership agreement is adopted by the Board of County Commissioners, the County shall own any fiber optic line installed at county expense as of the passage of this resolution and will authorize the County Administrator to enter into agreements with various political subdivisions to contract shared use of existing fiber optic lines at no cost to the County.
- 5. Until such time as an agreement is adopted by the Board of County Commissioners, the County shall own any fiber optic line installed as a result of this resolution and will require Board of Commissioner approval for shared use until such time as an ownership agreement is approved by the Board of County Commissioners.
- 6. The County Administrator and the Data Center Director will work with the Board of County Commissioner to establish the Delaware County Fiber Optic Steering Committee composed of members appointed by the Board of Commissioners. The Steering Committee will make policy recommendations to the Board of Commissioners, assist with the planning of the fiber optic network for Delaware County, and provide oversight for the development of an RFP to expand the fiber optic network in Delaware County. The Steering Committee will be co-chaired by the County Administrator and the Data Center Director.
