The Director of the Department of Natural Resources and/or Delaware County and/or their representatives may enter said lands for the purpose of inspection."

THEREFORE BE IT RESOLVED by the Board of Commissioners of Delaware County:

- 1. The Delaware County Board of Commissioners authorizes the Liberty Township Trustees to act as its authorized representative for inspecting and enforcing the ODNR Conservation Easement/Common Areas/Tree Preservation Easements (No-Cut Zones) in accordance with the Final Plat of the River Run Subdivision situated in Liberty Township, Ohio.
- 2. The Delaware County Board of Commissioners shall be notified in writing, by the Liberty Township Trustees, of any action taken pursuant to this resolution.
