A RESOLUTION IMPLEMENTING SECTIONS 3735.65 THROUGH 3735.70 OF THE OHIO REVISED CODE, ESTABLISHING AND DESCRIBING THE BOUNDARIES OF A COMMUNITY REINVESTMENT AREA IN ORANGE TOWNSHIP, DELAWARE COUNTY, DESIGNATING A HOUSING OFFICER TO ADMINISTER THE PROGRAM, AND CREATING A COMMUNITY REINVESTMENT HOUSING COUNCIL AND A TAX INCENTIVE REVIEW COUNCIL:

It was moved by Mr. Hanks, seconded by Mr. Thompson to approve the following:

WHEREAS, Delaware County desires to pursue all reasonable and legitimate incentive measures to assist and encourage development in specific areas of Orange Township that have not enjoyed reinvestment from remodeling or new construction; and

WHEREAS, a survey of housing, a copy of which is on file in the Delaware County Economic Development Department, as required by section 3735.66 of the Revised Code, has been prepared for the area to be included in the proposed Community Reinvestment Area; and

WHEREAS, the maintenance of existing and construction of new structures in such area would serve to encourage economic stability, maintain real property values, and generate new employment opportunities; and

WHEREAS, the remodeling of existing structures or the construction of new structures in this Community Reinvestment Area constitutes a public purpose for which real property exemptions may be granted; and

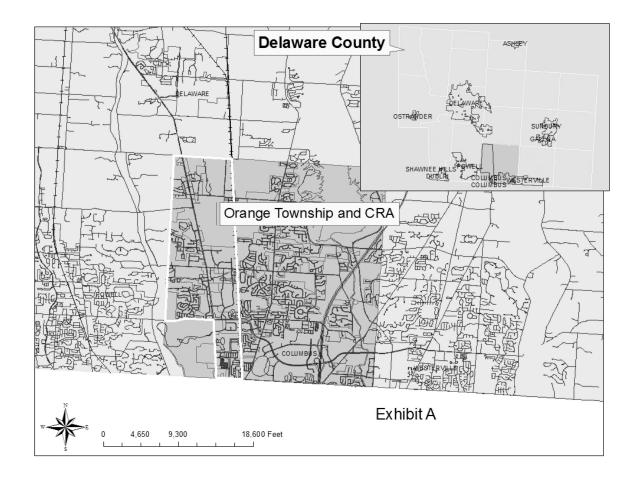
WHEREAS, the Orange Township Trustees recommended approval of the creation of the Orange Township Community Reinvestment Area per Resolution 10-337, passed on August 5, 2010.

NOW THEREFORE, PURSUANT TO THE FOREGOING, BE IT HEREBY RESOLVED by the Delaware County Commissioners, State of Ohio, as follows:

Section 1: The area designated as the Orange Township Community Reinvestment Area constitutes an area in which housing facilities or structures of historical significance are located, and in which new construction or repair of existing facilities or structures has been discouraged.

Section 2: Pursuant to section 3735.66 of the Revised Code, designation of the Orange Township Community Reinvestment Area, is hereby requested in the following described area: The CRA shall originate at the Northwest corner of Orange Township at the point of intersection of Orange, Liberty, and Berlin Townships, shall be bounded on the north by the Township line and shall follow an easterly course along the centerline of Hyatt Road and Shanahan Road; then it heads south with the eastern boundary being the midpoint between the two sets of railroad tracks owned by Norfolk Southern RR and CSX Transportation, respectively; it then heads west along the centerline of Lazelle Road, with the Delaware County line being the southern boundary of the CRA; then at the intersection of Lazelle Road and US-23 the line heads north following the centerline of US-23 to its intersection with Powell Road (SR750); continuing west on the centerline of West Powell Road to the Township line, then north following the western boundary of Orange Township to the CRA's point of origin. Areas in the City of Columbus are excluded.

The Orange Township Community Reinvestment Area is approximately depicted as the outlined area on the following map (see Exhibit A), which is attached hereto and, by this reference, incorporated herein. Only commercial and/or industrial properties consistent with the applicable zoning regulations within the designated Community Reinvestment Area will be eligible for exemptions under this Program.



Section 3: All commercially and industrially zoned properties identified in Exhibit A, being within the designated Community Reinvestment Area, are eligible for this incentive. The CRA is a public/private partnership intended to promote and expand conforming uses in the designated area. As part of the project, Delaware County intends to undertake supporting public improvements in the designated area.

Section 4: Applications for exemption from taxation shall be filed with the Housing Officer appointed herein. Applicants shall complete the standard Ohio Department of Development Business Application for Tax Incentives, which shall be made available upon request. Within the Community Reinvestment Area, the percentage of the tax exemption on the increase in the assessed valuation resulting from improvements to commercial and industrial real property and the term of those exemptions shall be negotiated on a case-by-case basis in advance of construction or remodeling occurring, in accordance with section 3735.67 of the Revised Code.

The Housing Officer shall review any and all applications for exemption from taxation submitted in accordance with section 3735.67 of the Revised Code. An Orange Township CRA Tax Incentive Negotiating Committee (TINC) is hereby established to assist and advise the Housing Officer in performing the Housing Officer's duties and responsibilities, pursuant to section 3735.67 of the Revised Code. The TINC shall consist of the following members: (1) the County Administrator or designee; (2) Olentangy Local School Board Superintendent or designee; and (3) an Orange Township Trustee or designee. The Housing Officer, in conjunction with the TINC, may present a tax exemption recommendation for consideration by the Orange Township Trustees prior to submission to the Delaware County Commissioners for final consideration. The final terms of any exemption from taxation shall be approved by the Delaware County Commissioners and set forth in a written Community Reinvestment Area Agreement as outlined in section 3735.671 of the Revised Code, a copy of which shall be certified to the director of the Ohio Department of Development.

Tax exemptions for residential structures are not authorized. Structures primarily used for residential purposes shall be considered residential structures.

For commercial and industrial properties, owners may request:

- a. Up to, and including, twelve (12) years (unless extended pursuant to section 3735.67(D)(3)), and up to, and including, fifty percent (50%) for the remodeling of existing commercial and industrial facilities and upon which the cost of remodeling is at least \$5,000, as described in section 3735.67 of the Revised Code, the term and percentage of which shall be negotiated on a case-by-case basis in advance of remodeling occurring.
- b. Up to, and including, fifteen (15) years, and up to, and including, fifty percent (50%) for the construction of new commercial or industrial facilities, the term and percentage of which shall be negotiated on a case-by-case basis in advance of construction occurring.

If remodeling qualifies for an exemption, during the period of the exemption, the exempted percentage of the dollar amount of the increase in assessed value of the structure shall be exempt from real property taxation. If new construction qualifies for an exemption, during the period of the exemption the exempted percentage of the structure shall not be considered to be an improvement on the land on which it is located for the purpose of real property taxation.

Section 5: All commercial and industrial projects are required to comply with the state application fee requirements of section 3735.672(C) of the Revised Code and the local annual monitoring fee of one percent of the amount of taxes exempted under the agreement—a minimum of \$500 up to a maximum of \$2500 annually, unless waived.

Section 6: To administer and implement the provisions of this resolution, the Delaware County Economic Development Director is designated as the Housing Officer, as described in sections 3735.65 through 3735.70 of the Revised Code.

Section 7: A "Community Reinvestment Area Housing Council" shall be created, consisting of one member appointed by each member of the Delaware County Board of Commissioners and two members appointed by the Delaware County Regional Planning Commission. The majority of the foregoing members shall then appoint two additional members who shall be residents of Orange Township within the Orange Township CRA. Terms of the members of the council shall be for three years. An unexpired term resulting from a vacancy in the council shall be filled in the same manner as the initial appointment was made. The Community Reinvestment Area Housing Council shall make an annual inspection of the properties within the district for which an exemption has been granted under section 3735.67 of the Revised Code. The Council shall also hear appeals under section 3735.70 of the Revised Code.

Section 8: A Tax Incentive Review Council shall be established, pursuant to section 5709.85(A)(2) of the Revised Code, and shall consist of three representatives appointed by the Delaware County Commissioners, two Orange Township resident-representatives appointed by the Orange Township Trustees, the county auditor or designee, and a representative from the Olentangy Local School District and the Delaware Area Career Center appointed by their respective Boards of Education.

The Tax Incentive Review Council shall review annually the compliance of all agreements involving the granting of exemptions for commercial or industrial real property improvements under section 3735.671 of the Revised Code and make written recommendations to the Delaware County Commissioners as to continuing, modifying, or terminating said agreements based upon the performance of the agreement.

Section 9: The Delaware County Commissioners reserve the right to re-evaluate the designation of the Orange Township Community Reinvestment Area after December 31, 2011, and annually thereafter, at which time the Council may direct the Housing Officer not to accept any new applications for exemptions as described in section 3735.67 of the Revised Code.

Section 10: The Delaware County Commissioners hereby find and determine that all formal actions relative to the passage of this resolution were taken in an open meeting of the Delaware County Commissioners, that all deliberations of the Delaware County Commissioners and of its committees, if any, which resulted in formal action were taken in meetings open to the public, in full compliance with the applicable legal requirements, including section 121.22 of the Revised Code.

Section 11: This resolution shall take effect and be enforced from and after the earliest period allowed by lawand upon confirmation by the Director of Development of the findings in this resolution.

Section 12: The President of the Board of County Commissioners is hereby authorized to petition the Director of Development to confirm the findings contained within this Resolution. The petition shall be made not later than fifteen days after adoption of this Resolution.

Section 13: The Clerk of the Board of County Commissioners is hereby directed to cause this Resolution to be published in a newspaper of general circulation in Delaware County once a week for two consecutive weeks immediately following adoption of this Resolution.
