#### Cheshire Road (CR#72) Speed Limit Reduction Request

As the result of a speed limit study prepared by our office, I request that your Board consider adoption of a Resolution to request the Ohio Department of Transportation to lower the speed limit on Cheshire Road between Domigan Road (TR#33) to the Village of Sunbury to 40 miles per hour.
