**WHEREAS**, the Delaware County Recorder ("Recorder") is in need of purchasing a comprehensive recording software solution ("Software") in order to record documents in the Delaware County Recorder's Office; and,

WHEREAS, the purchase shall be competitively bid according to Ohio Revised Code §§ 307.86 to 307.92; and,

**WHEREAS**, a Legal Notice ("Notice") and a Request for Bids ("RFB") have been prepared to competitively bid for the purchase of such Software.

#### NOW THEREFORE, BE IT RESOLVED BY THE BOARD:

#### SECTION 1. APPROVAL OF NOTICE AND RFB

- 2. The Recorder is authorized to place/advertise the Notice as required and permitted by applicable law; and,

- 4. The Recorder is authorized to release/let the RFB and receive bids on behalf of the Board.

#### **SECTION 2. ADOPTION**

All formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of this Board, and all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Bids for a comprehensive recording software solution for the Delaware County Recorder's Office (hereinafter "Recorder's Office") will be received by the Board of County Commissioners, Delaware County, Ohio (hereinafter "Board") and the Delaware County Recorder, Delaware County, Ohio (hereinafter "Recorder") (Board and Recorder hereinafter collectively "County") c/o Melissa Jordan, Delaware County Recorder, during standard business hours (8:30 a.m. to 4:30 p.m. Monday through Friday) beginning March 23, 2011 until 4:30 p.m. local time on March 29, 2011 at the Recorder's Office located at 140 North Sandusky Street. 1st Floor, Delaware, Ohio 43015. Bids received after this time and date shall not be considered and will be returned unopened. At 2:00 p.m. on March 31, 2011 at the Delaware County Commissioner's Meeting Room located at 101 North Sandusky Street, Delaware, Ohio 43015 bids will be publicly opened and read aloud. All bids shall be considered valid until sixty (60) days after the bid opening date although not accepted or rejected.

The Recorder's Office is responsible for recording, indexing, and maintaining land records for Delaware County, Ohio. To efficiently perform these and other related functions, the Recorder's Office utilizes a comprehensive recording software application (hereafter "Application"). Specifically, the Application electronically records, indexes, and images land records. The Application also performs cashiering functions and produces certain financial and statistical reports. The County seeks a single contractor to enter into a contract pursuant to which the contractor will furnish a comprehensive recording software solution ("Software") to perform these and other functions for the Recorder's Office in accordance with the detailed specifications contained within the Request for Bids (hereinafter "RFB").

An RFB containing the terms and conditions of this contract, together with detailed technical specifications and bid documents, can be obtained during regular business hours (8:30 a.m. to 4:30 p.m. Monday through Friday) beginning March 2, 2011 until 4:30 p.m. local time on March 16, 2011 at the Recorder's Office located at 140 North Sandusky Street. 1st Floor, Delaware, Ohio 43015.

Bids shall be submitted on the forms contained in the RFB, shall contain the full name and email address of each person, party, or parties submitting the bid and all persons interested therein, and shall be enclosed in a sealed opaque envelope addressed and submitted to Melissa Jordan, Delaware County Recorder, Delaware County Recorder's Office, 140 North Sandusky Street. 1st Floor, Delaware, Ohio 43015. The outside of the envelope shall be clearly marked: "Response to RFB for a Comprehensive Recording Software Solution for the Delaware County Recorder's Office"

Each bidder is required to furnish with its bid, bid security in accordance with Ohio Revised Code §§ 307.88 and 153.54, et seq. The bid security shall be a bond or certified check, cashier's check, or money order on a solvent bank or savings and loan association in an amount equal to five percent (5%) of the total price bid, conditioned that the bidder, if the bidder's bid is accepted, shall execute a contract in conformity with the RFB and the bid. Bid security furnished in bond form shall be issued by a surety company or corporation licensed in the State of Ohio to provide

said surety. All bid security shall be in favor of the Board of County Commissioners, Delaware County, Ohio.

A performance bond in the full amount of the bid shall be required from the successful bidder.
