Ohio (hereinafter "the County") and Correctional Healthcare Companies, Inc. (hereinafter "CHC") (hereinafter collectively referred to as "the Parties"). The Parties entered into an original agreement effective March 1, 2009 and, via amendments, extended through February 29, 2012 ("the Original Agreement").

Whereas, CHC was awarded a three year contract for providing healthcare services for detainees of the Delaware County Jail, pursuant to the Invitation to Bid ("ITB") issued on January 6, 2012; and

Whereas, while a long-term contract pursuant to the ITB is finalized, the Parties wish to enter into a short-term contract from March 1, 2012, through March 31, 2012;

Now, therefore, the Parties agree that effective March 1, 2012, the Parties shall enter into this Agreement, incorporating all provisions of the Original Agreement, subject to all amendments thereto, which expired on February 29, 2012, with the following exceptions:

Paragraphs 8.0 and 9.0 shall be deleted and amended to state as follows:

8.0 PAYMENT. The payment for services shall be Forty Thousand Three Hundred Forty-Five Dollars and Eight Cents (\$40,345.08) and shall be paid to CHC within fifteen (15) days after the County receives an invoice for that amount from CHC.

9.0 TERM. The term of this Agreement shall be from March 1, 2012, at 12:01 a.m. through March 31, 2012, at 11:59 p.m.
