The parties previously entered into a Memorandum of Understanding regarding the securing and funding of a position for a mental health professional to provide mental health services to persons incarcerated at the Delaware County Jail. Attached hereto as Exhibit "A" and incorporated herein is a copy of the Memorandum of Understanding currently in effect for the term March 10, 2014 through June 30, 2014 (the "MOU").

The parties now desire to extend the term of the MOU following its expiration on the following terms and conditions:

- 1. Memorandum Term. The MOU is hereby extended following its expiration on June 30, 2014 for an additional term of one (1) year commencing on July 1, 2014 and continuing to June 30, 2015 (the Board's FY 2015).
- 2. Financial Contributions. The Board is responsible for making payment to Maryhaven in the amount of \$77,000, to cover the professional and administrative costs for the mental health professional position to be staffed by Maryhaven during the term of this extension. The Sheriff agrees to reimburse the Board for 20% of this cost in the amount of \$15,400. Attached hereto as Exhibit "B" is the Budget for the position for FY 2015.
- 3. Obligations of the Parties. The parties agree to continue to provide the support and services as set forth in the MOU and such other services as they mutually agree will enhance the provision of mental health services at the Jail.

Except as modified herein, all of the terms and conditions of the MOU shall remain in full force during the period of this extension.

Maryhaven

Proposal for a Mental Health Clinician for Delaware County Jail Prepared for The Delaware- Morrow Mental Health & Recovery Services Board

Background:The Delaware County Sherriff has identified the need for a full-time mental healthprofessional in the jail. This position would be funded through an agreement with the Delaware-MorrowCounty Mental Health & Recovery Services Board and the Delaware County Sherriff's office.

Maryhaven will provide a full-time staff clinician that is licensed in the State of Ohio to provide mental health services including the diagnosis and treatment of mental and emotional disorders to offenders incarcerated in the Delaware County Jail. This position would be supervised by the Maryhaven Clinical Supervisor in Delaware County.

Maryhaven will conduct mental health assessments, crisis intervention, individual counseling, and casemanagement to include linkage to the appropriate services post release from the jail.

Cost Analysis: \$65,000 annually for 1 FTE employee

Includes:	•

Outcomes: To evaluate the effectiveness of the program the following information will be maintained: the total number of clients receiving services, the number of clients being successfully linked to services after release, the number of clients returning to the jail within 12 months from release.

Billing Procedure: To be determined.

Additional Information: An official job description will be developed in conjunction with Maryhaven, the Delaware County Sheriff's Department and the Delaware-Morrow Mental Health & Recovery Services Board.
