WHEREAS, this Board of County Commissioners, as the "organizational board of commissioners" pursuant to Ohio Revised Code Section 349.01(F), on August 10, 2006 adopted a Resolution organizing the Sunbury Meadows Community Development Authority (the "Authority") and establishing its seven (7) member Board of Trustees, all pursuant to Ohio Revised Code Chapter 349; and

WHEREAS, pursuant to Ohio Revised Code Section 349.04, this Board of County Commissioners generally has the authority to establish the manner of election of successor members of the Authority's Board of Trustees from among the qualified electors residing within the Authority's district; and

WHEREAS, HB 50 (129<sup>th</sup> General Assembly), enacted on December 13, 2012 and effective March 27, 2013 ("HB 50"), amends Ohio Revised Code Section 349.04 and authorizes this Board of County Commissioners to determine by resolution the manner in which the Authority may hold its own local elections, and this Board of

County Commissioners desires to authorize the Authority to hold its own local elections on the same date as the Authority's annual fiscal meeting, at such times, at such locations, and in such a manner as the Authority's Board of Trustees shall determine from time to time; and

# BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, COUNTY OF DELAWARE, STATE OF OHIO, THAT:

- 1. This Board of County Commissioners hereby determines that as the Authority meets the population benchmarks established pursuant to Ohio Revised Code Section 349.04, as amended by H.B. 50, and Resolution No. 09-808 of this Board of County Commissioners establishing election procedures for the Authority, such that elections are necessary for board positions, the Authority's Board of Trustees shall have the authority to hold local elections on the same date as the Authority's annual fiscal meeting, at such times, at such locations, and in such a manner as the Authority's Board of Trustees shall determine from time to time.
- 2. The Authority's Board of Trustees shall establish election procedures to govern all Authority elections, which shall include, without limitation, a two (2) week advance notice of the election date, time, and location, by U.S. Mail, to residents of the Authority district.
- 3. Candidates for election to the Authority's Board of Trustees shall each be qualified electors residing within the Authority's district and shall not be an employee or an agent of, or have financial interest in Dominion Homes, Inc., the initial developer of the Authority's district, or any of its affiliates.
- 4. The term of each elected member of the Authority's Board of Trustees term shall commence immediately upon election or as otherwise determined by the Authority's Board of Trustees and shall extend for a term of two (2) years, provided that election terms shall be staggered in accordance with the election procedures established by the Authority's Board of Trustees and consistent with Ohio Revised Code Sections 349.04 and 349.16. If a vacancy occurs in the office of an elected member of the Authority's Board of Trustees, this Board of County Commissioners may, but shall not be required to, appoint a successor member for the remainder of the unexpired term.
- 5. Pursuant to Ohio Revised Code Section 349.04, each member of the Authority's Board of Trustees, before entering upon their official duties, shall take and subscribe to an oath before an officer authorized to administer oaths in the State of Ohio that the member will honestly and faithfully perform the duties of their office. Each oath shall be filed in the office of the Clerk of this Board of County Commissioners. Each member of the Authority's Board of Trustees shall also post a bond for the faithful performance of their duties and give surety therefor in an amount not less than Ten Thousand Dollars (\$10,000), or in such other amount as may be required by Ohio Revised Code Chapter 349, as the same may be amended from time to time. The bond shall be with a company authorized to conduct business within the State of Ohio as a surety and shall be deposited with and preserved by the Delaware County Auditor.
- 6. This Board of County Commissioners finds and determines that all formal actions of this Board of County Commissioners concerning and relating to the adoption of this Resolution were taken in an open meeting of this Board of County Commissioners and that all deliberations of this Board of County Commissioners and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.
- 7. This Resolution may be amended, supplemented, and restated by this Board of County Commissioners.
- 8. This Resolution shall be in full force and effect immediately upon its adoption.
