THIS AGREEMENT, executed on this 17th day of November 2014 between HOMEWOOD CORPORATION, hereinafter called 'OWNER" and the BOARD OF COUNTY COMMISSIONERS OF DELAWARE COUNTY OHIO (COUNTY COMMISSIONERS), for the project described as SCIOTO RESERVE SECTION 4, PHASE 13, further identified as Project Number 13058 is governed by the following considerations to wit:
