Section 1: The Board hereby approves a compensation adjustment, effective March 14, 2015, for employees within the Code Compliance department who meet the following criteria:

- A. Employees must be full-time employees with at least one year of service with Delaware County Code Compliance.
- B. 0% adjustment with no cross training/acquisition of additional certification.
- C. 2.5% adjustment for inspectors possessing a residential building inspector certification (or equivalent) or a building inspector certification and successfully completing the necessary cross training as defined by the Director/designee.

- D. 5% adjustment for inspectors possessing a residential building inspector certification (or equivalent) <a href="mailto:and">and</a> a building inspector certification <a href="mailto:and">and</a> successfully completing the necessary cross training as defined by the Director/designee.
- E. 5% adjustment for plan examiners granted for increased state mandated competencies and standards and receiving necessary cross training as defined by the Director/designee.
- F. Employees previously granted a 2.5% adjustment (as defined in 1C) may receive an additional 2.5% adjustment for obtaining the additional certification and training (as defined in 1D).
- G. Total adjustments will not exceed 5%.
- H. If certification expires or if an individual no longer satisfies the cross training competency requirements (as defined by the Director/designee), the awarded compensation adjustment will be decreased by the amount previously granted.
- I. The certification requirements listed in 1C and 1D shall be a full certification, not an interim.

Section 2: The County Administrator shall consult with the Assistant County Administrator/Director of Administrative Services and the Director of Environmental Services to determine the employees that meet the eligibility criteria.
