WHEREAS, the Delaware County Board of Commissioners is proud to honor Larry Ufferman upon his retirement, and for his nearly thirty-one years of service to Delaware County and the state of Ohio as Delaware Soil and Water Conservation District (SWCD) Administrator; and

WHEREAS, he was born and raised in Delaware County and has seen its transformation from a quiet rural agricultural neighborhood into a dynamic bustling community comprised of a mixture of rural/urban neighbors, each with their own unique resource-related problems; and

WHEREAS, he has helped mold the SWCD's conservation program into one of the best in Ohio. Three times in his tenure, the SWCD has been recognized as having a top SWCD program by the Ohio Federation of SWCDs. His many years of service exemplify the SWCD's mission of "Helping You Help the Land";

Inter-Agency Agreement

This Agreement is entered into this 28th day of July, 2016, by and between the Village of Galena (the "Village") and the Delaware County Commissioners (the "County") for the administration of a Clean Ohio Trail Fund project as follows:

The Village of Galena is the applicant for a 2016 Clean Ohio Fund grant to pave an additional 1,775 feet section of the Ohio-Erie Trail (the "Project").

In accordance with the grant program requirements, the parties hereto have mutually agreed to the following division of responsibilities:

Funding: The County agrees to front the grant portion of the Project funding, estimated to be \$130,679.06. Upon receipt of grant funds for the Project, said funds shall be deposited with the County to reimburse the County's initial outlay of funds for the Project. The County shall have no financial responsibility for the Project over and above the grant funds. At least one (1) week prior to contract award for the Project, the Village shall provide or collect all remaining matching funds for the Project and cause said matching funds to be deposited with the County for application to the Project costs.

Administration: The County shall have authority to award any and all contracts in furtherance of the Project and shall have approval authority over any and all change orders thereto. The County shall administer payments to contractors and maintain all financial records for the Project. Bidding and construction administration shall be contracted to an engineering firm, subject to Chapter 163 of the Revised Code. Design and construction plans, including all modifications thereto, are subject to approval by both the Village and the County. The Village shall be a signatory to all contracts in furtherance of the Project.

Unforeseen Costs: Any unforeseen costs shall be paid from contingency funds set aside within the Project estimate. If unforeseen costs exceed the amount of contingency funds, the Village and County agree to modify the scope of the Project to reduce the cost to within budget limitations. In no event shall the County incur any costs over and above the reimbursable grant funds.

Communication and Records: As public records, all records pertaining to this Project shall be available for inspection during regular business hours. The County agrees to keep the Village well informed of the Project via the contract administrator, and the County shall provide to the Village any additional information regarding the Project upon request.

Ownership: The Village shall, at all times, hold ownership of the Project and shall retain all rights in this respect.

Maintenance: The Village shall be solely responsible for all maintenance for the Project. This maintenance includes, but is not limited to, keeping the trail open and free of tree limbs, grass mowing, and items in need of repair.

Termination: This Agreement shall terminate upon one of the following events: (a) the grant application is denied; (b) the Project is completed, including final payment and full reimbursement to the County; or (c) either party giving written notice of termination for convenience prior to the award of a construction contract for the Project. Notwithstanding termination of this Agreement pursuant to Section 7(b), Sections 5 and 6 of this Agreement shall continue in full force and effect.

- 1. To generally improve the drainage, both surface and subsurface, to a good and sufficient outlet by replacing or repairing, or altering the existing improvements as required and/or creating new surface and subsurface drainage mains or laterals as requested by this petition.
- 2. In Delaware County, Radnor Township within the Thomas #9 Watershed and generally following, but not limited to the course and termini of the existing improvement.

NOTE: the first hearing on the petition is scheduled for Thursday October 13, 2016, at 10:00am

The Commissioners:

-Looked At Breather from the old tile system at side of corn field along drive way.

-SWCD has Fiber Optic cameras that will check other Breathers after 1st hearing

-Followed Tile Areas along road way

-viewed "3B" Tile at Radnor and Troy (water from tree area to the north comes to this ditch area)

-Viewed Outlets On side of Radnor Road;

-the petition (signatures and words) determines the upstream part of a project the "sufficient outlet" determines the bottom of a project

-the 1920's and earlier infrastructure in this area would predates maintenance program.

-projects since 1998 are automatically placed on County Drainage Maintenance Program -this is a landowner initiated process and detailed surveys follow if the project moves past the first hearing -if approved the storm water infrastructure will be placed on the County Drainage Maintenance Program -if approved money pooled only for this project; assessments placed on build-able lots current and future
