#### Background:

In a Memorandum of Understanding between the parties effective July 1, 2016 (Board's FY 2017), Board made a grant to Sheriff to be utilized by Sheriff for the employment of an individual to fill the full-time position of Substance Abuse Liaison. The Board in combination with other local agencies has determined to continue funding to support the staffing and services to be provided by the Substance Abuse Liaison.

Now Therefore, the Parties Agree as Follows:

- 1. **Grant Award**.
