WHEREAS, pursuant to the Act and certain public hearings, including a hearing held by the County Hospital Commission of Franklin County on September 27, 2017, and a hearing held by this Board of County Commissioners on October 12, 2017, Franklin County anticipates issuing its (i) Hospital Facilities Revenue Refunding and Improvement Bonds, Series 2017A (Nationwide Children's Hospital Project) and (ii) Hospital Facilities Revenue Refunding and Improvement Bonds, Series 2017B (Nationwide Children's Hospital Project) (together, the "Series 2017 Bonds") in an aggregate principal amount not to exceed \$150,000,000, the proceeds of which are to be used by Nationwide Children's Hospital, an Ohio nonprofit corporation (the "Corporation") to refinance the costs of the acquisition, construction, installation and equipping of certain "hospital facilities" located within the County of Franklin, Ohio, and the County of Delaware, Ohio;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Delaware, Ohio, that:

Section 1. <u>Approval</u>. The issuance of the Series 2017 Bonds is hereby approved by this Board, as an "applicable elected representative" of Delaware County, solely for the purpose of satisfying the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended. Based on representations of the Corporation, the proceeds of the Series 2017 Bonds will be used for the purpose of (i) financing a portion of the acquisition, construction, equipping and installation

of improvements to the buildings and facilities of the Corporation, including but not limited to, a behavioral health pavilion, an administrative building, parking garage and the West Campus Energy Plant and the acquisition and equipping of other routine capital expenditures of the Corporation, including reimbursing the Corporation for costs previously incurred for such projects, all of which will be located at or adjacent to the main campus of the Corporation located at 700 Children's Drive, Columbus, Ohio, (ii) refunding on a current basis all or a portion of the Issuer's \$46,620,000 original principal amount Variable Rate Demand Hospital Revenue Refunding Bonds, Series 2008D (Nationwide Children's Hospital), dated May 7, 2008, which refunded and retired the Issuer's Variable Rate Demand Hospital Revenue Bonds, Series 2003 (The Children's Hospital Project) which financed or refinanced the acquisition, construction, renovation and equipping of Hospital Facilities, as defined in the Act, including a building for the Children's Drive, Columbus, Ohio and an ambulatory care center located at 433 Cleveland Avenue, Westerville, Ohio, and (iii) paying certain costs of issuance of the Series 2017 Bonds. The primary user of the facilities financed and refinanced from the proceeds of the Series 2017 Bonds is presently expected to be the Corporation.

Section 2. <u>No Obligation</u>. The costs of issuance of the Series 2017 Bonds shall be paid from the proceeds of the Series 2017 Bonds, or from moneys made available by the Corporation. The Series 2017 Bonds do not constitute a general obligation, debt or bonded indebtedness of Franklin County or this County and neither the faith or credit or taxing power of Franklin County or this County or any other political subdivision is pledged to the payment of principal of or interest on the Series 2017 Bonds and the holders or owners thereof shall not be given the right and have no right to have excises or taxes levied by Franklin County or this County for the payment of principal of and interest thereon. Further, no part of the Series 2017 Bonds are to be issued, or shall be deemed issued, for or on behalf of this County.

Section 3. <u>Bond Terms</u>. The terms and provisions of the Series 2017 Bonds shall be as provided for in or pursuant to resolutions of the County Hospital Commission of Franklin County and the Board of County Commissioners of Franklin County authorizing the issuance, sale and delivery of the Series 2017 Bonds.

Section 4. <u>Execution of Other Documents</u>. Any member of this Board, the Clerk of this Board, and other County officials, as appropriate, are each authorized and directed to sign any transcript certificates and other documents and instruments and to take such actions as are necessary or appropriate to consummate the transactions contemplated by this Resolution.

Section 5. <u>Compliance with Open Meeting Requirements</u>. This Board finds and determines that all formal actions of this Board concerning and relating to the adoption of this resolution were taken in an open meeting of this Board and that all deliberations of this Board and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

Section 6. <u>Effectiveness</u>. This Resolution shall be in full force and effect immediately upon its adoption.
